

**STIPULATION OF BECHMARK PRICES OF
NATURAL PLANTS AND WILD ANIMALS NOT PROTECTED BY THE LAW**
(Decree of the Minister of Industry and Trade No. 476/MPP/Kep/8/2004 dated August 18, 2004)

THE MINISTER OF INDUSTRY AND TRADE,

Considering:

- a. that in the framework of implementing the provision in Article 3 of Government Regulation No. 59/1998 on tariffs of non-tax state revenues effective within the Ministry of Forestry and Plantations, as already amended by Government Regulation No. 74/1999, it is necessary to stipulate benchmark prices of natural plants and wild animals not protected by the law;
- b. that in relation thereto, a decree of the Minister of Industry and Trade needs to be issued;

In view of:

1. Law No. 20/1997 (BN No. 6101 pages 9A - 14A and so on) on non-tax state revenues (Statute Book of 1997 No. 43, Supplement to Statute Book No. 3687);
2. Government Regulation No. 59/1998 (BN No. 6236 pages 1A - 5A and so on) on tariffs of non-tax state revenues effective within the Ministry of Forestry and Plantations (Statute Book of 1998 No. 94, Supplement to Statute Book No. 3767), as already amended by Government Regulation No. 74/1999 (BN No. 6399 pages 4A - 6A) (Statute Book of 1999 No. 137);
3. Presidential Decree No. 260/1967 on affirmation of tasks and responsibility of the Minister of Trade in the foreign trade sector;
4. Presidential Decree No. 228/M/2001 (BN No. 6650 pages 29A - 30A) on the establishment of the Mutual Cooperation Cabinet;
5. Presidential Decree No. 102/2001 on the status, tasks, functions, authority, organizational structures and working arrangements of ministries;
6. Presidential Decree No. 109/2001 on first-echelon organizational units and tasks of ministries;

7. Decree of the Minister of Industry and Trade No.558/MPP/Kep/SK/12/1998 (BN No. 6252 pages 10A - 12A and so on) on export general provisions as already amended several times and the latest by Decree of the Minister of Industry and Trade No. 385/MPP/Kep/6/2004;
8. Decree of the Minister of Industry and Trade No. 86/MPP/Kep/3/2001 on the organization and working arrangement of the Ministry of Industry and Trade;

Observing:

The agreement on results of inter-ministerial meeting with institutions and associations concerned on March 30,2004 on stipulation of benchmark prices of natural plants and wild animals not protected by the law.

D E C I D E S :

To stipulate:

THE DECREE OF THE MINISTER OF INDUSTRY AND TRADE ON STIPULATION OF BECHMARK PRICES OF NATURAL PLANTS AND WILD ANIMALS NOT PROTECTED BY THE LAW.

Article 1

- (1)Benchmark prices of natural plants and wild animals not protected by the law are levies imposed as substitutes to intrinsic value of output collected from natural plants and wild animals.
- (2)The benchmark prices as meant in paragraph (1) are based on market prices, which constitute the average weighted selling prices of forest products effective on the domestic and international markets.

Article 2

- (1)The benchmark prices as meant in Article 1 paragraph (2) are as mentioned in the attachment to this decree.
- (2)The benchmark prices as meant in paragraph (1) are effective for 6 (six months) starting from the date of stipulation of this decree.
- (3)In the case of the validity period of the benchmark prices as meant in paragraph (2) expiring and the new benchmark prices being not stipulated yet, the benchmark prices as meant in paragraph (1) are used for calculating levies on natural plants and wild animal not protected by the law until the new benchmark prices are stipulated.

Article 3

The decree comes into force as from the date of stipulation.

For public cognizance, the decree shall be published by placing it in State Gazette of the Republic of Indonesia.

AMENDED SEVERAL TIMES AND LATEST BY DECREE OF
THE SAID MINISTER NO. 519/MPP/Kep/8/2003**

MINISTER OF INDUSTRY AND TRADE OF

Considering:

- a. that, in the framework of improving of effectiveness in the implementation and supervision over policy on export of products of forest and mining industries and in the framework of protection and conservation of natural resources and adjustment of classification of goods based on the 2004 Harmonized System (HS), it is necessary to amend Appendix to Decree of the Minister of Industry and Trade as amended several times and latest by Decree of the said minister No. 519/MPP/Kep/8/2003 and re-stipulate goods, which export is organized, supervised, and prohibited;
- b. that, in relation to the above matter, it is necessary to issue Decree of the Minister of Industry and Trade.
