

**REGISTRATION AND ISSUANCE OF
FIXED LICENSES TO TECHNICAL SUBSTANCES OF PESTICIDES**
(Decree of the Minister of Agriculture No. 223/Kpts/SR.140/4/2004 dated April 13,2004)

THE MINISTER OF AGRICULTURE,

(Statute Book of 1995 No. 12, Supplement to Statute Book No. 3586);

Considering:

- a. that the quality of formulas of pesticides and impacts of their use are heavily dependent on the quality of their technical substances;
 - b. that applications for registration of technical substances of pesticides which are submitted have been evaluated and deemed fulfilling the stipulated requirements;
 - c. that based on the above mentioned matters and in accordance with the provision in Article 20 of Decree of the Minister of Agriculture No. 434.1/Kpts/TP/270/7/2001 on requirements and procedures for registration of pesticides, it is deemed necessary to register and issue license to the technical substances of pesticides as meant in letter b;

DECIDES :

To stipulate :

THE DECREE OF THE MINISTER OF AGRICULTURE ON REGISTRATION AND ISSUANCE OF FIXED LICENSES TO TECHNICAL SUBSTANCES OF PESTICIDES

Article 1

- (1) The technical substances of pesticides as contained in column 2 of the attachment to this decree shall be registered and given the fixed license as meant in Article 20 of Decree of the Minister of Agriculture No. 434.1/Kpts/TP.270/7/2001 on requirements and procedures for registration of pesticides on behalf of the registration holders as contained in column 6, no. of registration as contained in column 7 of the attachment to this decree.
- (2) The fixed license as meant in paragraph (1) shall be valid for 5 (five) years, starting from the date of issuance of this decree.
- (3) The registration holders as meant in paragraph (1) shall be given license to distribute and issue information on the technical substances of the pesticides in accordance with the law in force.
- (4) The status as the registration holders as meant in paragraph (1) can be reviewed if the registration holders are no longer appointed to register the technical substances by the producers of the technical substances or fail to meet the provisions in the law in force.
- (5) Applications for re-registration of the technical substances as meant in paragraph (1) shall be submitted not later than 2 (two) months before the expiration of the license.

Article 2

The technical substances of the pesticides as meant in Article 1 shall contain the active substances as meant in column 3, minimum content of active substances as contained in column 4 and form of technical substance as contained in column 5 of the attachment to this decree.

Article 3

The technical substances as meant in Article 1 only can be stored and distributed in original container, wrapper and label in accordance with the provisions in Decree of the Minister of Agriculture No. 434.1/Kpts/TP.270/7/2001 on requirements and procedures for registration of pesticides and other provisions in force.

Article 4

The technical substances as meant in Article 1 only can be used for producing formulas of pesticides already registered.

Article 5

- (1) The registration holders shall guarantee that the registered technical substances shall meet the requirements for the quality, container, wrapper and label as well as other provisions stipulated in the registration document.
- (2) The registration holders only can distribute the technical substances of pesticides that they register, to holders of registration of formulas of pesticides containing active substances, which are the same as technical substances of pesticide that they register.
- (3) The registration holders shall convey report to the Directorate General of Agricultural Facility Development on the registered technical substance when they are given up to registration holders of formulas not later than one month after the delivery.

Article 6

The license as meant in Article 1 paragraph (1) can be amended, replaced or revoked if the technical substances are not in accordance with the law in force, cause the unexpected side effects or are ascertained to have certain dangerous potential previously unknown.

Article 7

The decree shall come into force as from the date of stipulation.
