

THE REGISTRATION AND TECHNICAL MATERIALS OF PESTICIDES
(Decree of the Minister of Agriculture and Forestry No. 506/Kpts/TP.270/10/2000
dated October 27, 2000)

THE MINISTER OF AGRICULTURE AND FORESTRY,

Considering :

- a. that the quality of pesticide formulations and the impact of their use is very dependent on the quality of their technical materials;
- b. that applications for the registration of technical materials of pesticides have been evaluated and consideration and in accordance with Article 10 of Decree of the Minister of Agriculture No. 280/Kpts/Um/6/1973, it is deemed necessary to register and license the technical materials of pesticides as referred to in letter b;

In view of :

3. Law No. 23/1997 on a environmental management (Statute Book of 1997 No. 68, Supplement to Statute Book No. 3699);
4. Government Regulation No. 7/1973 on the control of the circulation, storing and use of pesticides (Statute Book of 1973 No. 12);
5. Government Regulation No. 6/1995 on plant protection (Statute Book of 1995 No. 12, Supplement to Statute Book No. 3586);
6. Presidential Decree No. 136/1999 on the position, task, function, organization structure and working system of a ministry;
7. Presidential Decree No. 234/M/2000 on the formation of a new cabinet for the 1999 - 2004 period;
8. Decree of the Minister of Agriculture No. 280/Kpts/Um/6/1973 on the procedure for applying for the registration of pesticides adj. Decree of the Minister of Agriculture No. 761/Kpts/TP.270/9/98 on a change in the amount of fees for the registration of pesticides;

Observing :

The view of the Pesticides Commission in its letter No. 417/Kompes/2000 dated September 18, 2000;

DECIDES :

To stipulate :

THE DECREE OF THE MINISTER OF AGRICULTURE AND FORESTRY ON THE REGISTRATION AND TECHNICAL MATERIALS OF PESTICIDES

Article 1

- (1) The technical materials of pesticides as referred to in column 2 of the Attachment to this Decree shall be registered and granted permanent permits as referred to in Article 7 of Decree of the Minister of Agriculture No. 280/Kpts/Um/6/1973, in the name of registration holders as referred to in column 6, registration numbers as referred to in column 7 of the Attachment to this Decree.
- (2) The permanent permits shall be valid for 5 (five) years starting from the issuance date of this Decree.
- (3) The registration holders as referred to in paragraph (1) shall be licensed to circulate and issue information on the technical materials of pesticides as referred to in paragraph (1) in accordance with the existing rules.
- (4) The status of registration holders as referred to in paragraph (4) shall be reviewed if the registration holders are no longer appointed by the relevant producers of the technical materials to register the technical materials or do not comply with the existing rules.
- (5) Applications for the re-registration of technical materials as referred to in paragraph (1) shall be filed no later than the expire date of the permits as referred to in paragraph (2).

Article 2

The technical materials of pesticides as referred to in Article 1 paragraph (1) shall have active materials as contained in column 3 with a minimum active material content as contained in column 4 and form as contained in column 5.

Article 3

The technical materials of pesticides as referred to in Article 1 paragraph (1) can only be stored and circulated in packs and containers with origin labels in accordance with Decree of the Minister of Finance No. 429/Kpts/Um/9/1973 and other existing rules.

Article 4

The technical materials of pesticides as referred to in Article 1 paragraph (1) can only be used for the manufacture of registered pesticide formulations.

Article 5

- (1) The registration holders as referred to in Article 1 paragraph (1) shall be put under an obligation to ensure that the technical materials of pesticides to be registered have fulfilled quality, packing and labeling requirements as referred to in Article 2 and Article 3 and have met other provisions as contained in the registration documents.
- (2) The registration holders as referred to in Article 1 paragraph (1) shall only be allowed to circulate the technical materials of pesticides they have registered, among registration holders of pesticide formulations containing the same active materials as the technical materials of pesticides they have registered.

- (3) The registration holders as referred to in Article 1 paragraph (1) shall be put under an obligation to send the Pesticide Commission a report on the technical materials they have registered any time when they are delivered to formulation registration holders, no later than 1 (one) month after the date of delivery.

Article 6

The permits as referred to in Article 1 paragraph (1) can be changed, replaced or revoked if the technical materials of pesticides as referred to in Article 1 paragraph (1) prove that they do not agree with the existing rules, cause unexpected side-effects, or have the potentials of causing unpredictable dangers.

Article 7

This Decree shall begin to take effect on the date of stipulated.
