

**NATIONAL POLICY AND STRATEGY OF
RUBBISH MANAGEMENT SYSTEM DEVELOPMENT (KSNP - SPP)**

(Regulation of the Minister of Public Works No. 21/PRT/M/2006 dated September 15, 2006)

BY GRACE OF GOD THE ALMIGHTY

THE MINISTER OF PUBLIC WORKS,

Considering:

- a. that in the framework of sustainable sanitation of resettlement environment, environmentally friendly rubbish management system needs to be developed;
- b. that healthy resettlement with clean environment is badly needed for enhancing the quality of public health in Indonesia so as to make them more productive;
- c. that in a bid to realize the expected healthy resettlement as meant in letters a and b, integrated, efficient and effective plans, programs and implementation of activities are needed;
- d. that in order to realize the expected condition and situation as meant in letter c, it is necessary to stipulate national development policy and strategy of rubbish management system by a regulation of the Minister of Public Works;

Observing:

1. The Need for National Development Policy and Strategy of Rubbish Management System as a guidance for sanitation of resettlement environment as mandated by Government Regulation No. 16/2004;
2. Declarations of the United Nations Meetings, particularly Habitat Declaration and Agenda 21 in Rio de Janeiro on Adequate Shelter for Human and Sustainable Resettlement Development which needs to be realized in national policy and strategy of resettlement rubbish treatment;
3. UN Millenium Summit in September 2000, resulting in Millenium Development Goals (MDGs) in the framework of realizing a better living environment;

DECIDES :

To stipulate :

**THE REGULATION OF THE MINISTER OF PUBLIC WORKS
ON NATIONAL DEVELOPMENT POLICY AND STRATEGY
OF RUBBISH MANAGEMENT SYSTEM**

Article 1

Referred to in this regulation as:

1. National Development Policy and Strategy of Rubbish Management System, hereinafter abbreviated to KSNP-SPP constitutes guidelines on regulation, implementation and development of rubbish management system for the central and regional governments, business communities, private and society.

2. KSNP-SPP covers descriptions of visions and missions of development of rubbish management system, strategic issues, problems and challenges of SPP development, goals/targets as well as national development policies and strategies of rubbish management system and the required action plans.

Article 2

KSNP-SPP is used as guidance for regulating, implementing and developing environmentally friendly rubbish management system in the central and regional levels in accordance with conditions of local regions.

Article 3

More detailed technical regulations and operational guidelines in the regulation, implementation and development of rubbish management system system as elaboration of KSNP-SPP need to be formulated and stipulated further by the institutions concerned.

Article 4

(1) In the case of regions not yet having the regulation as meant in Article 2, provisions and plans for the development of rubbish management system in the regions need to be prepared and stipulated by regional regulation, referring to this ministerial regulation.

(2) In the case of regions already having regional regulation on the development of rubbish management system before the issuance of this regulation, the regional regulation should be adjusted on the basis of the provisions as meant in this regulation.

Article 5

With the enforcement of this regulation, regulation, formulation of plans, programs and implementation of development activities of rubbish management system must refer to this regulation.

Article 6

- (1) The regulation comes into force as from the date of stipulation and it shall be amended and rectified accordingly in the case of mistake being found.
- (2) The regulation is disseminated to the parties for information and proper implementation.
