



GOVERNMENT REGULATIONS

THE TARIFFS OF DUTIES ON THE IMPORT OF CERTAIN DAIRY PRODUCTS

(Regulation of the Finance Minister No. 101/PMK.011/2009 dated May 28, 2009)

THE FINANCE MINISTER

Considering :

- a. that to support the development of the domestic dairy industry, it is necessary to change the tariffs of duties on the import of certain dairy products;
- b. that in consideration of the matter in letter a and in an effort to implement provisions in Article 12 paragraph (3) of Law No. 10/1995 on Customs Affairs as has been amended by Law No. 17/2006, it is necessary to stipulate Regulation of the Finance Minister on the Tariffs of Duties on the Import of Certain Dairy Products;

In view of :

1. Law No. 7/1994 on the Ratification of Agreement Establishing the World Trade Organization (Statute Book of 1994 No. 57, Supplement to Statute Book No. 3564);
2. Law No. 10/1995 (*BN No. 5812 pages 19A-20A and so on*) on Customs Affairs (Statute Book of 1995 No. 75, Supplement to Statute Book No. 3612) as has been amended by Law No. 17/2006 (*BN No. 7476 pages 23A-27A*) (Statute Book of 2006 No. 93, Supplement to Statute Book No. 4661);
3. Presidential Decree No. 20/P/2005 (*BN No. 7297 pages 29A-30A*);
4. Regulation of the Finance Minister No. 110/PMK.010/2006 (*BN No. 7765 pages 1A-19A*) on the Systems of Classifying Goods and Charging the Tariffs of Duties on Imported Goods as has been several times amended the latest by Regulation of the Finance Minister No. 233/PMK.011/2008;

DECIDES :

To stipulate :

REGULATION OF THE FINANCE MINISTER ON THE TARIFFS OF DUTIES ON THE IMPORT OF CERTAIN DAIRY PRODUCTS.

Article 1

The Finance Minister shall set the tariffs of duties on the import of certain dairy products as contained in Attachment to this Regulation of the Finance Minister which is an integral part of this Regulation of the Finance Minister.

Article 2

This Regulation of the Finance Minister shall apply to the import of goods whose import customs notification has secured registration number from the Customs Office at the port of entry.

Article 3

With the enforcement of this Regulation of the Finance Minister, provisions on the tariffs of import duties as laid down in Regulation of the Finance Minister No. 19/PMK.011/2009 on the Tariffs of Duties on the Import of Certain Products, shall be declared null and void, provided they deal with the products as referred to in Attachment to this Regulation of the Finance Minister.

Article 4

This Regulation of the Finance Minister shall come into force as from the date of stipulation.

For public cognizance, this Regulation of the Finance Minister shall be promulgated by placing it in the State Gazette of the Republic of Indonesia.
