

**THE AMENDMENT TO REGULATION OF THE DIRECTOR GENERAL OF
FOREIGN TRADE NO. 03/DAGLU/PER/4/2009 ON GUIDANCE
TO IMPLEMENT REGULATION OF THE TRADE MINISTER
NO. 13/M-DAG/PER/3/2009 ON AMENDMENT TO REGULATION OF
THE TRADE MINISTER NO. 12/M-DAG/PER/4/2008
ON PROVISIONS ON THE IMPORT AND EXPORT OF RICE**

(Regulation of the Director General of Foreign Trade No. 04/DAGLU/PER/6/2009 dated June 1, 2009)

THE DIRECTOR GENERAL OF FOREIGN TRADE,

Considering :

That to support the effective implementation of provisions on the export of rice as laid down in Regulation of the Trade Minister No. 13/M-DAG/PER/3/2009 on Amendment to Regulation of the Trade Minister No.12/M-DAG/PER/4/2008 on Provisions on the Import and Export of Rice, it is necessary to stipulate a Regulation of the Director General of Foreign Trade;

In view of :

1. Presidential Decree No. 34/M/2005 on the Appointment of First Echelon Officials at the Trade Ministry;
2. Decree of the Industry and Trade Minister No. 558/MPP/PER/Kep/12/1998 (*BN No. 6354 pages 10A-12A and so on*) on General Provisions in the Export Sector as has been several times amended the latest by Regulation of the Trade Minister No. 01/M-DAG/PER/1/2007 (*BN No. 7475 pages 17A-25A*);
3. Regulation of the Trade Minister No. 12/M-DAG/PER/4/2008 (*BN No. 7672 pages 1A-12A*) on the Import

and Export of Rice as has been amended by Regulation of the Trade Minister No. 13/M-DAG/PER/3/2009 (*BN No. 7798 pages 5A-8A*);

4. Regulation of the Director General of Foreign Trade No. 03/DAGLU/PER/4/2009 (*BN No. 7816 pages 21A-24A*) on Guidance to Implement Regulation of the Trade Minister No. 13/M-DAG/PER/4/2009 on Amendment to Regulation of the Trade Minister No. 12/M-DAG/PER/4/2008 on Provisions on the Import and Export of Rice;

DECIDES :

To stipulate :

THE REGULATION OF THE DIRECTOR GENERAL OF FOREIGN TRADE ON AMENDMENT TO REGULATION OF THE DIRECTOR GENERAL OF FOREIGN TRADE NO. 03/DAGLU/PER/4/2009 ON GUIDANCE TO IMPLEMENT REGULATION OF THE TRADE MINISTER NO. 13/M-DAG/PER/3/2009 ON AMENDMENT TO REGULATION OF THE TRADE MINISTER NO. 12/M-DAG/PER/4/2008 ON PROVISIONS ON THE IMPORT AND EXPORT OF RICE.

Article I

Provisions in Article 9 paragraph (1), paragraph (2) and paragraph (4) shall be amended so that Article 9 reads as follows:

Article 9

- (1) The Trade Minister shall issue export approvals of pre-shipment to the applications as referred to in Article 8 paragraph (3) for rice of medium category.
- (2) The Director General of Foreign Trade under the name of the Trade Minister shall issue export approvals of pre-shipment to the applications as referred to in Article 8 paragraph (3) for rice of premium category.
- (3) The export approvals as referred to in paragraph (1) and paragraph (2) shall be issued no later than 5 (five) working days after the applications have been received in a complete and correct manner.
- (4) The export approvals as referred to in paragraph (2) for rice of premium category shall be valid for a period of 30 (thirty) days and issued during a rice harvest time set at a meeting of the Coordinating Team of Staple Food Stability, while export approvals for sticky rice and organically-processed rice can be issued throughout the year and shall be valid for a period of 3 (three) months after the date of issuance.

Article II

This Regulation of the Director General shall come into force as from the date of stipulation.
