

THE AMENDMENT TO REGULATION OF THE MINISTER OF FORESTRY NO. P.19/MENHUT/II/2007 CONCERNING PROCEDURE FOR THE GRANTING OF PERMITS AND THE EXPANSION OF BUSINESS WORK AREAS UTILIZING FOREST WOOD PRODUCT IN INDUSTRIAL PLANTATION FORESTS WITHIN CULTIVATION FORESTS IN PRODUCTION FORESTS.

(Regulation of the Minister of Forestry No. P.60/Menhut-II/2007, dated December 17, 2007)

THE MINISTER OF FORESTRY

Considering:

- a. that based on Regulation of the Minister of Forestry No. P.19/Menhut/II/2007, procedure for the granting of permits and expansion of Business Work Areas Utilizing Forest Wood Products in Industrial Plantation Forests within Cultivation Forests in Production Forests had been stipulated;
- b. that the granting of permits for business utilizing Forest Wood Products in Industrial Plantation Forests within Cultivation Forests prior to the stipulation of the Regulation of the Minister of Forestry referred to in letter a, was made through quotations in bids;
- c. that in the performance of the quotations in the bids referred to in letter b, the winner of the bid for the permit for business utilizing Forest Wood Products in Industrial Plantation Forests, had been stipulated;
- d. that for the purpose of providing legal certainty in the settlement process of IUPHHK in Cultivation Forests referred to in letter c, it is deemed necessary to amend Regulation of the Minister of Forestry No. P.19/Menhut/II/2007 concerning Procedure for the granting of Permits and Expansion of Business Work Areas Utilizing Forest Wood Products in Industrial Plantation Forests within Cultivation Forests in Production Forests, with a decree of the Minister of Forestry.

11. Decree of the Minister of Forestry No. SK.101/Menhut-II/2005 concerning Acceleration of the Development of Cultivation Forests to Supply Raw Material for Pulp and Paper Industries which had been perfected several times, lastly by No. P.44/Menhut-II/2005;
12. Regulation of the Minister of Forestry No. P.13/Menhut-II/2005 concerning Organization Structure and Procedure of the Forestry Department which had been perfected several times, lastly by No. P.17/Menhut-II/2007;
13. Regulation of the Minister of Forestry No. P.19/Menhut-II/2007 concerning Procedure for the granting of Permits and Expansion of Business Work Areas Utilizing Forest Wood Products in Industrial Plantation Forests within Cultivation Forests in Production Forests.

DECIDES :

To stipulate:

THE REGULATION OF THE MINISTER OF FORESTRY CONCERNING THE AMENDMENT TO REGULATION OF THE MINISTER OF FORESTRY NO. P.19/MENHUT/II/2007 CONCERNING PROCEDURE FOR THE GRANTING OF PERMITS AND EXPANSION OF BUSINESS WORK AREAS UTILIZING FOREST WOOD PRODUCTS IN INDUSTRIAL PLANTATION FORESTS WITHIN CULTIVATION FORESTS IN PRODUCTION FORESTS.

Article I

To amend Article 15 paragraph (1) of Regulation of the Minister of Forestry No. P.19/Menhut/II/2007 concerning Procedure for the Granting of Permits and Expansion of Business Work Areas utilizing Forest Wood Products in Industrial Plantation Forests within Cultivation Forests in Production Forests as follows:

Article 15

- (1) Application for Business Permits for the Utilization of Forest Wood Products in Industrial Plantation Forests within Cultivation Forests (IUPHHK-HT) through IUPHHK bidding which had been awarded a stipulation as bid winner, shall be processed based on regulations before the stipulation of Regulation of the Minister of Forestry No. P.19/Menhut/II/2007.

Article II

This regulation comes to effect from the date of stipulation.
