

## S.I. No. 386 of 2003

### European Communities (Pesticide Residues) (Cereals) (Amendment) (No. 2) Regulations 2003

2002<sup>28</sup>, Commission Directive 2003/60/EC of 18 June 2003<sup>29</sup> and Commission Directive 2003/62/EC of 20 June 2003<sup>30</sup> hereby make the following Regulations-

1. (1) These Regulations may be cited as the European Communities (Pesticide Residues) (Cereals) (Amendment) (No. 2) Regulations 2003.  
  
(2) These Regulations come into operation in respect of fentin hydroxide, fentin acetate and chlorfenapyr on 1 July 2004.

2. The European Communities (Pesticide Residues)(Cereals) Regulations 1999 (S.I. No. 181 of 1999) is amended in Regulation 2(1) by substituting for “the Directive”-
