

**S.I. No. 385 of 2003**

**European Communities (Pesticide Residues) (Foodstuffs of Animal Origin)  
(Amendment) (No. 2) Regulations 2003**

1. These Regulations may be cited as the European Communities (Pesticide Residues) (Foodstuffs of Animal Origin) (Amendment) (No. 2) Regulations 2003.
2. The European Communities (Pesticide Residues)(Foodstuffs of Animal Origin) Regulations 1999 (S.I. No. 180 of 1999) is amended in Regulation 2 (1) by substituting for “the Directive”-
