## European Communities (Identification and Registration of Bovine Animals) (Amendment) Regulations, 2002

3. Regulation 2 (1) of the 1999 Regulations is hereby amended by the insertion of the following :

"animal event sheet" means the document set out in the Seventh Schedule insofar as it relates to Section 1a and the Declaration for National Bovine Animal Birth Registration of that document ;

4. Regulation 3 of the 1999 Regulations is hereby amended by the addition of the following subparagraphs :

" or

(d) return the information required on the application form in an electronic format as may be determined by the Minister, or

or

(e) complete and return an animal event sheet to the National Calf Birth Registration Service."

5. The 1999 Regulations are hereby amended by the addition of the Seventh Schedule annexed hereto.
