**European Communities (Pesticide Residues) (Cereals)
(Amendment) (No. 2) Regulations 2006**

I, Mary Coughlan, Minister for Agriculture and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No.27 of 1972) and for the purpose of giving effect to Commission Directive 2005/70/EC of 20 October 2005¹, Commission Directive 2005/76/EC of 8 November 2005², Commission Directive 2006/4/EC of 26 January 2006³ and Commission Directive 2006/30/EC of 13 March 2006⁴, hereby make the following Regulations-

1. These Regulations may be cited as the European Communities (Pesticide Residues) (Cereals) (Amendment) (No. 2) Regulations 2006.
2. The European Communities (Pesticide Residues) (Cereals) Regulations 1999 (S.I. No 181 of 1999) are amended –
 - (a) in Regulation 2(1) by the substitution, for the definition of “Directive” (inserted by the European Communities (Pesticide Residues) (Cereals) (Amendment) Regulations 2006 (S.I. No. 108 of 2006)), of –

Explanatory Note

(This note is not part of the Instrument and does not purport to be a legal interpretation)

These Regulations amend existing regulations on the fixing of maximum residue levels for pesticides in and on cereals.

Commission Directive 2005/70/EC amends the levels of bromoxynil, chlorpropham, dimethenamid-P, flazasulfuron, flurtamone, ioxynil, mepanipyrim, propoxycarbazone, pyraclostrobin, quinoxyfen, trimethylsulfonium cation, zoxamide and glyphosate.

Commission Directive 2005/76/EC amends the levels of kresoxim-methyl, cyromazine, bifenthrin, metalaxyl and azoxystrobin.

Commission Directive 2006/4/EC amends the levels for carbofuran.

Commission Directive 2006/30/EC amends the levels for the benomyl group.
