AGRICULTURE AND FOOD (DELEGATION OF MINISTERIAL FUNCTIONS) ORDER 2004.

The Government, on the request of the Minister for Agriculture and Food, and in exercise of the powers conferred on them by section 2(1) of the Ministers and Secretaries (Amendment) (No. 2) Act 1977 (No. 28 of 1977), hereby order as follows:

1. This Order may be cited as the Agriculture and Food (Delegation of Ministerial Functions) Order 2004.
2. The powers and duties of the Minister for Agriculture and Food conferred on her—

(a) by or under the enactments specified in Part 1 of the Schedule to this Order,

(b) by the Regulations made under section 3 of the European Communities Act 1972 (No. 27 of 1972) specified in Part 2 of the Schedule to this Order, and

(c) by or under—
(i) the Local Government Acts 1925 to 2001, and
(ii) the Local Authorities (Officers and Employees) Acts 1926 to 1983,

in so far as they relate to an enactment specified in Part 1 or Regulations specified in Part 2 of that Schedule, as respects the office, or the holder of the office of, inspector or veterinary inspector appointed by a local authority, are delegated to John Browne, Minister of State at the Department of Agriculture and Food.
