AGRICULTURE AND FOOD (DELEGATION OF MINISTERIAL FUNCTIONS) (No. 2) ORDER 2004.

The Government, on the request of the Minister for Agriculture and Food, and in exercise of the powers conferred on them by section 2 (1) of the Ministers and Secretaries (Amendment) (No. 2) Act 1977 (No. 28 of 1977), hereby order as follows:
