(RESTRICTION ON IMPORTS) (AMENDMENT) REGULATIONS 2007

I, MARY COUGHLAN, Minister for Agriculture and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving effect to Commission Decision 2007/137/EC of 23 February 2007¹, hereby make the following regulations—

1. These Regulations may be cited as the European Communities (Classical Swine Fever) (Restriction on Imports) (Amendment) Regulations 2007.

2. The European Communities (Classical Swine Fever) (Restriction on Imports) Regulations 2007 (S.I. No 130 of 2007) are amended in Regulation 2(1) by substituting the following for the definition of “Commission Decision”—

“ ‘Commission Decision’ means Commission Decision No 2006/805/EC of 24 November 2006 and Commission Decision 2007/137/EC of 23 February 2007;”.

(This note is not part of the Instrument and does not purport to be a legal interpretation)


These regulations concern import derestrictions due to the improvement of incidence of Classical Swine Fever in certain parts of Germany.
