EUROPEAN COMMUNITIES (DIRECT SUPPORT SCHEMES)
REGULATIONS 2010

I, BRENDAN SMITH, Minister for Agriculture, Fisheries and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) for the purpose of giving full effect to Council Regulation (EC) No. 73/2009 of 19 January 2009¹, Commission Regulation (EC) No. 1120/2009 of 29 October 2009², Commission Regulation (EC) No. 1122/2009 of 30 November 2009³, Council Regulation (EC) No. 1257/1999 of 17 May 1999⁴, Commission Regulation (EC) No. 817/2004 of 29 April 2004⁵, Council Regulation (EC) No. 1698/2005 of 20 September 2005⁶, Commission Regulation (EC) No. 1974/2006 of 15 December 2006⁷, Commission Regulation (EC) No. 1975/2006 of 7 December 2006⁸, hereby make the following Regulations:

1. These Regulations may be cited as the European Communities (Direct support schemes) Regulations 2010.

2. The European Communities (Agriculture, Fisheries and Food) (Compliance) Regulations 2009 (S.I. No. 424 of 2009) (as amended by the European Communities (Marketing Standards) (Crops and Oils) Regulations (S.I. No. 153 of 2010) are applied to the acts of the institutions of the European Union detailed in the Schedule.
