

RESOLUTIONS

Resolution No. (40)

Date : 19th. Dhul- Qidda, 1415 H.

19-4-1995 A.D.

In accordance with the provisions of Para. (A) of Article (42) of the Constitution.

The Revolution Command Council have decided the following

Firstly - 1- It is restricted with the state of marketing the wheat, Barley, rice (Shilib), maize, and seeds of sunflower by the prices defined by the State .

2- The Council of Ministers may add other agricultural products to the materials stipulated in Para. (1) of this Item.

Secondly : Harvesting and Marketing Committees in administrative units (The Governorate/ Qadha/Nahia) shall undertake of directing the warning against contravenor who usufructs the agricultural land whether he is owning or has the right of disposal or lessor or has a contract with the State and did not deliver the quantity required from him that he must deliver thereof during (10) ten days on the date of being notified

Thirdly - If whoever did not deliver the warning sent to him the quantity required from him during the period stipulated in Item (Secondly), therefore it shall be taken from him the following :-

1. The Committee shall fine the contravenor who sold less than (100%) hundred percent to a limit of (75%) seventy five percent of the quantity required from him with the commercial price equivalent vaule of the rest quantity with the commercial price in the time of marketing, and in case of not paying the amount of the fine, he will be detained until payment.

2- The central committee shall fine the contravenor who markets less than (75%) seventy five percent to a limit of (50%) Fifty percent from the quantity required from him the amount equivalent to a

double of the rest quantity's value by the commercial price in the time of marketing and to imprison him for a period not less than one year and not to exceed (3) three years and he will not be discharged until he pays the fine amount.

3- The central committee shall fine the contravenor who markets less than (50%) Fifty percent of the quantity required from him a sum equivalent to the double of the rest quantity with the commercial rice in the time of marketing, and imprisoning him for a period not less than (3) three years as well as terminating his lease contract of the agricultural land leased to him by the State and he shall not be discharged until he pays the amount of the fine.

4- The judgements issued according to this Item shall be final.

Fourthly - 1 - The head of harvesting and Marketing committee has the right to order the searching in any place or depot or building including premises, in any time of taking the possession (seizin) on the materials covered by the provisions of this Resolution.

2- Without prejudice with the provisions of Item (Thirdly) of this Resolution - in case of seizin had been done, - during the inquests - on the materials covered by the provisions of this Resolution, the committee of the harvesting and marketing shall decide their seizure and deliver them to the sites of consignment attached to the ministry's concerned.

Fifthly -1- A ratio of 40% fourty percent of the value of the confiscated materials according to Para. (2) of Item (Fourthly) of this Resolution shall be distributed pursuant to the current price in the time of marketing, to the harvesting and marketing committee in the administrative unit where the seizin had been done therein and for those carrying out the execution

by halves.

2- In case of the information occurred toward of existing the materials covered by the provisions of this Resolution from any of the citizen, he shall be granted (50%) Fifty percent from the ratio stipulated in Para. (1) of this Item and a ratio of the (other fifty percent) shall be distributed by halves between the committee and those carrying out with the execution.

Sixthly - The competent ministers are charged with the execution of the provisions of this Resolution.

Seventhly - The Revolutionary Command Council Resolution No. (136) of 16-5-1991 (as amended) shall be cancelled.

Eighthly - This Resolution shall be implemented from the date of its publication in the Official Gazette.

Regulations

In accordance with the provisions of Para. (6) of the Revolution Command Council Resolution No. (136) of 1993.

Do hereby order the promulgation of the following Internal Regulation:-

No. (1) of 1995

Amending the Internal Regulation of Saddam

Centre For Cardiosurgery No. (1) of 1993

Article -

The two Items (3) and (5) of Para. (D / Secondly) of Article (4) of the Internal Regulation of Saddam Center for Cardiosurgery No. (1) of 1993 shall be deleted and substituted by the following.

(3) granting the encouragement remunerations for the distinguished of the centre's staff,

for centre from other than its staff not to exceed (3000) three thousand Dinars for each case.

(5) Disbursing the hospitality expenses not to exceed (3000) three thousand Dinars monthly.

Article Two: This Regulation shall come into force from the date of its promulgation.
