Annual registration fee of 0.4% of the unimproved value of the land, however, where this formula results in the fee attributable to a strata lot based on its unit entitlement amounting to more than twelve thousand dollars per annum, the percentage paid shall be reduced to 0.3% of the unimproved value of the land or such lower percentage so that the maximum fee attributable to a strata lot does not exceed \$12,000 per annum.
