THE NATURAL RESOURCES CONSERVATION (NEGRIL ENVIRONMENTAL
PROTECTION AREA) (DECLARATION) ORDER, 1997

(Made by the Minister on the 28th day of November, 1997, on the
recommendation of the Authority)

1. This Order may be cited as the Natural Resources Conservation
(Negril Environmental Protection Area) (Declaration) Order, 1997.

2. The area set out in Part I of the Schedule which is delineated on
the map set out in Part II thereof, is hereby declared to be an environ-
mental protection area and shall be known as the Negril Environmental
Protection Area.

SCHEDULE (Paragraph 2)

PART I. *Area of Negril Environmental Protection Area*

Commencing at the mouth of the Davis River along its course to a point where the Green Island to Lucea main road meets the Davis Cove to Lucea secondary road; then south-easterly along that secondary road to where it meets the Spring Mountain Parish Council road No. 29; then south-westerly to the point where the Parish Council road No. 29 crosses the Look Out River; then south-westerly to a point where a track meets the northern boundary of the Spring Mount Property; then southerly along that track to where it meets a Parish Council road; then along that Parish Council road to where it meets the Prospect to Paradise secondary road about 60.3 metres from the Community Hall; then easterly along the Prospect to Paradise secondary road to where it meets Parish Council road No. 22, about 100.5 metres from the Pell River School; then north-easterly along the Grange Hill to Pell River Parish Council road No. 22 to where it meets the Spring Valley to Mountain Parish Council road No. 29 at Spring Mountain; then south-easterly along Parish Council road No. 29 to its junction with Parish Council road No. 51 at Hog River Bridge; then south-easterly along Parish Council road No. 51 to where it crosses a tributary of the Hog River approximately 5 metres east of the private road leading to the Paradise Great House; then south-easterly along that tributary to its source in Peddy's Place; then south-westerly in a straight line to the north-western corner of the Glasgow Property boundary; then southerly to a point where the western boundary of the Glasgow Property intersects with the Glasgow to Green Island secondary road at the Baptist Church; then south-

westerly and then north-westerly along the Glasgow secondary road to where it meets the Parish Council road No. 19 about 80.4 metres south of Kendal School; **then south-westerly along that road to where it becomes a track; then south-westerly along that track to where it meets Parish Council road No. 17 opposite Gertrude Davis' house; then south-westerly along the Parish Council road No. 19 to where it meets Rock Spring Parish Council road No. 16; then south-easterly along that Parish Council road to the boundary of the parish of Hanover with the parish of Westmoreland marked by a sign; then south-westerly along that parish boundary to where it meets the Orange Bay Mountain track; then southerly along the Green Valley to Moreland Hill secondary road to the No. 3 post; then southerly to the No. 4 post on the Delve Bridge to Moreland Hill secondary road; then southerly along the secondary road to where it meets the Delve Bridge to Spring Garden Parish Council road at Delve Bridge; then north-westerly along the tributary of the Negril River to where it meets the Little London secondary road; then easterly along that secondary road to where it meets the New Hope Parish Council road; then north-easterly along the New Hope Parish Council road to where it meets the western boundary of Masemure; then northerly along that boundary to the Delve Bridge to Little London secondary road; then easterly and then south-easterly along that secondary road to where it meets the Parish Council road No. 8; then south-easterly from the New Hope Bridge along the New Hope Parish Council road to where it meets Drummond Lodge Parish Council road; then south-westerly to where the Drummond Lodge Parish Council road crosses the New Savanna River; then along this river to its mouth; then to a point 3.2 kilometres (marked as Point 1 on the map) due south of the seaward boundary between Westmoreland enumeration districts W70 and W71; then to a point 3.2 kilometres (marked as Point 2 on the map) due south from Salmon Point (also called South West Point on topographic maps); then to a point 3.2 kilometres (marked as Point 3 on the map) due south-west from Salmon Point (also called South West Point on topographic maps); then to a point 3.2 kilometres (marked as Point 4 on the map) due south-west from Sunset Point, then to a point 3.2 kilometres (marked as Point 5 on the map) due west from West Point at the Negril Lighthouse; **then to a point 3.2 kilometres (marked as Point 6 on the map) due west from South Negril Point; then to a point 3.2 kilometres (marked as Point 7 on the map) due west from north Negril Point; then to a point 3.2 kilometres (marked as Point 8 on the map) due north-west from North Negril Point; then to a point 3.2 kilometres (marked as Point 9 on the map) due north-west from Orange Point, off Ireland Pen; then to a point 3.2 kilometres (marked as Point 10 on the map) due north-west from South-west Point west of Green Island; then to a point 3.2 kilometres (marked as Point 11 on the map) due north-west of Negro Bay Point; then to a point 3.2 kilometres (marked as Point 12 on the map) due north-west of Davis Cove, then back to the starting point.****
