LEGAL NOTICE NO. 3

THE WILDLIFE (CONSERVATION AND MANAGEMENT) ACT

(Cap. 376)

IN EXERCISE of the powers conferred by section 16 of the Wildlife (Conservation and Management) Act, the Minister for Forestry and Wildlife makes the following Regulations:—

THE WILDLIFE (CONSERVATION AND MANAGEMENT) (NATIONAL PARKS) (AMENDMENT) REGULATIONS, 2013

1. These Regulations may be cited as the Wildlife (Conservation and Management) (National Parks) (Amendment) Regulations, 2013 and shall come into operation on the 1st February, 2013.

2. The Wildlife (Conservation and Management) (National Parks) Regulations 2010 hereinafter referred to as the “principal Regulations” are amended by inserting the following new regulation immediately after regulation 2—

2A One extra entry may be permitted within twenty four hours in any National Park or National Reserve except for Sanctuaries, Lake Nakuru National Park and Nairobi National Park.

3. Regulation 10 of the principal Regulations is amended by adding the following new subparagraph immediately after subparagraph (k)—

(1) Helicopter landing in Mt. Kenya National Park...US\$ 250.

4. Regulation 11 of the principal Regulations is amended—

(a) in subparagraph (a)—

(i) in the second column—

(aa) by deleting the expression “500” for Premium parks and substituting therefor the expression “1000” ;

(bb) by deleting the expression “300” for Wilderness parks and substituting therefor the expression “500”;

(ii) in the fourth column—

(aa) by deleting the expression “60” for Premium parks and substituting therefor the expression “80” ; (bb) by deleting the expression “75” for Premium parks and substituting therefor the expression “80”;

(cc) by deleting the expression “50” for Wilderness parks and substituting therefor the expression “65”;

(dd) by deleting the figure “60” for Wilderness parks and substituting therefor the figure “65”;

(iii) by inserting the following new column immediately after the expression “3 Day

package”—

*4-Day climbing package

(Sirimon, Chogoria, Kamweti,

Naromoru) 2000 3500 220

*5- Day climbing package

(Marania) 3000 5250 270

(b) in subparagraph (b), by inserting the following new column immediately after the expression “3 Day package”—

*4-Day climbing package

(Sirimon, Chogoria, Kamweti,

Naromoru) 2000 3500 220

*5- Day climbing package

(Marania) 3000 5250 270

5. The principal Regulations are amended in Part V, paragraph (b) by inserting the following new expression immediately after the expression “Fishing (per line) Per day 500”.

“Fishing (Mt. Kenya) Per day 1500”.
