THE AGRICULTURE (SUGAR-CANE MARKETING) RULES

1. These Rules may be cited as the Agriculture (Sugar-cane Marketing) Rules.
2. (1) All sugar-cane growers named in the first column of the Schedule shall sell to the factories shown in relation to their names in the third column thereof all sugar-cane grown in the areas specified in the second column thereof:

Provided that the above requirement shall not apply to a sugarcane grower who has the written permission of the appropriate factory to use the sugar-cane for planting purposes.

(2) Any sugar-cane grower who fails to comply with the provisions of paragraph (1) shall be guilty of an offence.
3. (1) No owner of a factory named in the third column of the Schedule shall buy sugar-cane from any other person except the sugar-cane growers shown in relation to his factory in the first column thereof.

(2) Any owner of a factory who fails to comply with the provisions of paragraph (1) shall be guilty of an offence.
4. Any person who is guilty of an offence under these Rules shall be liable to a fine not exceeding ten thousand shillings and to imprisonment for a term not exceeding six months or to both.
