

THE DECREE
OF THE PRESIDENT OF THE KYRGYZ REPUBLIC

(Edited version of Decree of the President of KR
of January, 4, 2002 # 3)

On the State Forestry Service of the Kyrgyz Republic

With a view of development and execution of uniform national forestry policy, maintenance of ecological safety and preservation of a biological diversity of the nature of republic, the further development of forestry complex management and effective conducting the hunting economy, and considering the application of group of deputies and the regulations of National Representatives Chamber of Jogorku Kenesh (Parliament) of the Kyrgyz Republic of November, 16, 2001 and taking into account opinion of the Swiss partner of the Kyrgyz-Swiss forestry support program, it is decided:

1. To form the State Forestry Service of the Kyrgyz Republic (further - the State Forestry Service) on the basis of the Forestry Development Department, Central Hunting Economy and Hunting Resources Use Administrative Board, Biodiversity Preservation and Specially Protected Natural Territories Development Sector of the Ministry of Environment and Emergencies of the Kyrgyz Republic.

To establish, that:

- The State Forestry Service is the state executive agency to conduct uniform policy in the field of forest protection, forestry and hunting economy of the Kyrgyz Republic and not included in structure of the Government of the Kyrgyz Republic;

- Chairman of the State Forestry Service is appointed the President of the Kyrgyz Republic on consultation with the Prime minister of the Kyrgyz Republic.

2. State Forestry Service to develop and submit in a month period in the established order:

- The draft of Provision on the State Forestry Service and the management scheme for its structural divisions, the subordinated organizations, the enterprises and establishments;

- Structure, staff number and conditions of payment to employees of the State Forestry Service.

3. The Government of the Kyrgyz Republic jointly with the State Forestry Service in the established order in the bi-monthly term:

- To transfer to the State Forestry Service the structural divisions of the Forestry Development Department, Central Hunting Economy and Hunting Resources Use Administrative Board, Biodiversity Preservation and Specially Protected Natural Territories Development Sector of the Ministry of Environment and Emergency of the Kyrgyz Republic, and subordinated organizations, enterprises and establishments, and managed material and logistics property;

- To solve the organizational, financial and other issues implying from the present Decree;

- To bring the decisions into accord with the present Decree.

4. In the second paragraph the sub item a) item 4 of the Decree of the President of the Kyrgyz Republic " On reorganization of the central state bodies" of December, 28, 2000 of №363 to exclude the words: " and

the State agency on forestry under the Government of the Kyrgyz Republic
".

5. The control over execution of the present Decree to assign to the Division of Organizational Operations and State Policy of the President's Administration of the Kyrgyz Republic.

6. The present Decree inures from the date of signing.
