THE DECREE
OF THE PRESIDENT OF THE KYRGYZ REPUBLIC

On issues of the State Forestry Service of the Kyrgyz Republic

With a view of effective realization of provisions of the Forestry Code of the Kyrgyz Republic, and further development forestry complex, specially protected natural territories and the hunting economy of republic, it is decided:

1. To endorse proposed Provision on the State Forestry Service of the Kyrgyz Republic, its management scheme and central administration structure.

2. To establish limiting number of employees of central administration of the State Forestry Service of the Kyrgyz Republic in quantity of 27 persons (without the personnel on service and protection of a building) and payment fund within the limits of the funds, envisaged in the republican budget.

3. The Government of the Kyrgyz Republic:

- To solve the organizational, financial and other issues implying from the present Decree;

- To prepare and submit in Jogorku Kenesh (Parliament) of the Kyrgyz Republic the drafts of the corresponding laws implying from the present Decree;

- To bring the decisions into accord with the given Decree.

4. In item 4 of the Decree of the President of the Kyrgyz Republic " On the State Forestry Service of the Kyrgyz Republic " of November, 25, 2001 №342 replace the words of "the subitem б)" with words of "the subitem а".

5. To introduce to a part 1 of the State Posts Lists of Public Service of the Kyrgyz Republic, stated in the attachement to the Decree of the President of the Kyrgyz Republic "On ammendments to the Decree of the President of the Kyrgyz Republic "On the endorsement of the State Posts Roster of the Kyrgyz Republic" of July, 3, 2000" of the December, 7, 2001 №356, the following changes and ammendments:

- In the senior posts "The State posts of civil servants of the bodies subordinated to the Ministry of environment and emergencies of the Kyrgyz Republic" chapter 2, the unit VIII "the State posts of civil servants of the separate ministries" to exclude the posts of director of national zapovednik, the deputy director of national zapovednik;

- In the senior posts of the unit IX "the State posts of civil servants of administrative agencies, the State Forestry Service of the Kyrgyz Republic" after a post of the head of division in structure of management to add by separate line a post sector manager;

- In section XIV "the State posts of civil servants of the province, rayon and city bodies subordinated to administrative agencies and the state commissions of the Kyrgyz Republic":

the unit's name after s word "agencies" to add by words ", the State Forestry Service";

In the senior posts after a post of the deputy chief of a province, Bishkek municipal government, inspection to add by separate lines a post of director of national zapovednik, deputy director of national zapovednik.

6. The control over execution of the present Decree to assign to the Department of organizational operations and state policy of the President's administration of the Kyrgyz Republic.

7. The present Decree inures from the date of signing.
