

# **MALAYSIAN RUBBER BOARD (LICENSING) (AMENDMENT) REGULATIONS 2005**

## **PU(A) 497/2005**

IN exercise of the powers conferred by section 62 of the Malaysian Rubber Board (Incorporation) Act 1996 [Act 551], the Minister makes the following regulations:-

1 December 2005

### **1. Citation and commencement**

(1) These regulations may be cited as the Malaysian Rubber Board (Licensing) (Amendment) Regulations 2005.

(2) These Regulations come into operation on 1 December 2005.

### **2. Amendment of regulation 12**

The Malaysian Rubber Board (Licensing) Regulations 1997 [P.U. (A) 516/1997], which are referred to as the "principal Regulations" in these Regulations, are amended in regulation 12 by inserting after subregulation (2) the following subregulation:-

"(2A) If a licence is issued, the licence shall be signed by the Chairman of the Licensing Panel or an officer authorized by the Chairman of then Licensing Panel."

### **3. Amendment of regulation 13**

Regulation 13 of the principal Regulations is amended:-

(a) by inserting after subregulation (2) the following subregulations:-

"(2A) The Licensing Panel shall, on an application having been duly made in accordance with subregulation (2), consider the application.

(2B) After considering the application and the suitability of the applicant for the renewal of the licence, the Licensing Panel may renew the licence in Form 4, with or without conditions, or refuse the renewal.

(2C) If the licence is renewed, the licence shall be signed by the Chairman of the Licensing Panel or an officer authorized by the Chairman of the Licensing Panel"; and

(b) by substituting for subregulation (3) the following subregulation:-

"(3) The provisions of subregulations 12(3) and (4) shall apply for the purposes of this regulation."

### **4. Amendment of regulation 27**

Regulation 27 of the principal Regulations is amended, in the English language text:-

(a) in the marginal note, by substituting for the word "Certificate" the word "Certified"; and

(b) in subregulation (1), by substituting for the word "certificate" the word "certified".

## **5. Amendment of regulation 33**

Subregulation 33(1) of the principal Regulations is amended in the English language text, by substituting for the word "Chirman" the word "Chairman".

## **6. Amendment of Second Schedule**

The Second Schedule to the principal Regulations is amended in Form 4:-

(a) by substituting for the words "Regulation 12" the words "Regulations 12 and 13";

(b) by substituting for the figure "1998" the figure "1997"; and

(c) by substituting for the words "Chairman, Licensing Panel" the words "Chairman of the Licensing Panel/Officer Authorized by the Chairman of the Licensing Panel".
