

**ANIMALS (FEES FOR THE QUARANTINE OF ANIMAL, BIRD OR THING IN FEDERAL
ANIMAL QUARANTINE STATIONS) RULES 2008**

PU(A) 115/2008

IN exercise of the powers conferred by subsection 81(2) of the **Animals Act 1953**[Act 647], the minister hereby prescribes the fees for the quarantine of any animal, bird or thing in the federal animal quarantine stations established under this Act.

1. Citation

These rules may be cited as the **Animals (Fees for the Quarantine of Animal, Bird or Thing in Federal Animal Quarantine Stations) Rules 2008**.

2. Fee

The following fees prescribed shall be charged for the quarantine of any animal, bird or thing in any federal animal quarantine stations established under subsection 80(1) of the Act:

(a) Bird

(i) Boarding

(1-10 birds) RM 5.00 per head per day

(11-100 birds) RM 2.00 per head per day

(every subsequent bird after 100 birds) RM 1.00 per head per day

(ii) Quarantine certificate RM 2.00 per consignment

(b) Dog

(i) Boarding RM 10.00 per head per day

(ii) Quarantine certificate RM 2.00 per head

(iii) Anti-rabies vaccination RM 25.00 per head

(iv) Microchip RM 100.00 per head

(c) Cat

(i) Boarding RM 5.00 per head per day

(ii) Quarantine certificate RM 2.00 per head

(d) House

(i) Boarding	RM 20.00 per head per day
(ii) Quarantine certificate	RM 2.00 per head
(e) Cattle and camel	
(i) Boarding	RM 2.00 per head per day
(ii) Quarantine certificate	RM 2.00 per head
(f) Sheep and goat	
(i) Boarding	RM 0.50 per head per day
(ii) Quarantine certificate	RM 1.00 per head
(g) Deer	
(i) Boarding	RM 0.50 per head per day
(ii) Quarantine certificate	RM 2.00 per head
(h) Chicken, duck, goose and ostrich	
(i) Boarding	
(1-10 birds)	RM 5.00 per head per day
(11-100 birds)	RM 2.00 per head per day
(every subsequent bird after 100 heads)	RM 1.00 per head per day
(ii) Quarantine certificate	RM 2.00 per consignment
(i) Pig	
(i) Boarding	RM 1.50 per head per day
(ii) Quarantine certificate	RM 2.00 per head
(j) Other animals	
(i) Boarding	RM 10.00 per head per day
(ii) Quarantine certificate	RM 2.00 per head

3. Laboratory test fees

If any laboratory test has been done under an order of the state director or officer in charge on any animal, bird or thing in the federal animal quarantine stations, the laboratory test fees shall be charged against the owner or the importer.

4. Revocation

The prescribed fees for the quarantine of animals in Padang Besar Animal Quarantine station as published in *L.N. 279/1958* is revoked.
