

Curepipe (sale of articles outside markets) Regulations 2010

GN No. 29 of 2011

THE LOCAL GOVERNMENT ACT

Regulations made by the Municipal Council of Curepipe under Sections 62, 64 and 142 of the Local Government Act 1989

1. These regulations may be cited as the **Curepipe (sale of articles outside markets) Regulations 2010**.

2. In these regulations:-

"Authorised Officer" means the Health Inspector of the Council or such officer as may be designated by the Council

"Council" means the Municipal Council of Curepipe.

"Identity Card" means the card issued under regulation 4.

"Market" has the same meaning as the Curepipe Market.

"Permit" means a permit issued under section 102 of the Local Government Act 2003.

"Space or Shop" means the space on a Municipal property destined for carrying on a trade.

3. No person shall sell articles otherwise than in spaces or shops and markets unless he is holder of a permit.

4. (1) Every space or shop occupier shall in the form prescribed in the Fourth Schedule apply in his own name for an identity card issued by the Council

(2) No person other than holders of identity cards shall be authorized to have access or trade within the space or shop as specified in First Schedule.

5. Every space or shop occupier shall at times, during operation:
 - (a) wear ostensibly the Identity Card issued by the Council
 - (b) produce the Identity card on demand to an authorized officer.
6. Every space or shop occupier shall enter into a contract with the Council.
7. Every space or shop occupier shall:-
 - (a) keep clean the premises;
 - (b) keep clean the space;
 - (c) deposit or cause to be deposited all refuse in receptacles which he shall provide for that purpose;
 - (d) abide by the provisions laid down in these regulations, the Curepipe (Market and Slaughter Houses) Regulations, the Food Act and the Legal Metrology Act.
8. (1) The Council may issue permits for the sale of articles outside markets in spaces or shops against payment of such fees as specified in the Second Schedule.

(2) Such payment shall be payable monthly in advance and not later than the eighth day of every month.
9. No person shall sell articles other than those specified on the permit.
10. The permit shall be issued subject to the condition that the Council may think fit to impose including the duration thereof.
11. Any application for a permit shall be made in accordance with the form laid out in the Third Schedule.
12. Any person who contravenes any of these regulations shall commit an offence and shall, on conviction, be liable to a fine not exceeding 10,000.00 rupees.

13. The Council may seize or confiscate any article which is the subject matter of the breach of these regulations and any such articles shall be disposed of in such manner as Council may decide.
14. Subject to the provisions of section 61(3) of the Local Government Act 1989, the Council reserves the right to rescind the contract of such space occupier, by notice in writing whereupon the space occupier shall forthwith vacate the stall without any indemnity whatsoever and without the need for any judicial process.
15. These Regulations shall come into force on the day of its publication.


