THE CONSUMER PROTECTION (PRICE AND SUPPLIES CONTROL) ACT

Regulations made by the Minister under section 35 of the Consumer Protection (Price and Supplies Control) Act

- 1. These regulations may be cited as the **Consumer Protection (Control of Imports) (Amendment No. 5) Regulations 2013.****

- 2. In these regulations —**
“principal regulations” means the Consumer Protection (Control of Imports) Regulations 2004.

- 3. Regulation 9 of the principal regulations is amended —**
 - (a) in paragraph (1)(a), by deleting the figure “50,000” and replacing it by the figure “60,000”;

 - (b) in paragraph (1)(aa), by deleting the figure “100,000” and replacing it by the figure “120,000”;

 - (c) in paragraph (1)(b), by deleting the figure “5,000” and replacing it by the figure “6,000”;

 - (d) in paragraph (2)(a), by deleting the figure “50,000” and replacing it by the figure “60,000”;

 - (e) in paragraph (2)(b), by deleting the figure “5,000” and replacing it by the figure

“6,000”.

4. Regulation 10(3) of the principal regulations is amended —
 - (a) in subparagraph (b)(i), by deleting the figure “15,000” and replacing it by the figure “20,000”;
 - (b) in subparagraph (c)(ii)(B), by deleting the figure “100,000” and replacing it by the figure “120,000”;
 - (c) in subparagraph (d)(i), by deleting the figure “50,000” and replacing it by the figure “60,000”;
 - (d) in subparagraph (d)(ii), by deleting the figure “5,000” and replacing it by the figure “6,000”;
 - (e) in subparagraph (e), by deleting the figures “50,000” and “5,000” and replacing them by the figures “60,000” and “6,000”, respectively.
5. Regulation 11 (B)(2) of the principal regulations is amended by deleting the figure “100,000” and replacing it by the figure “120,000”.
6. The Fifth Schedule to the principal regulations is amended, in item 4A—
 - (a) in subparagraph (iii), by deleting the full stop and replacing it by the words”; and”;
 - (b) by adding the following new subparagraph —
 - (iv) be covered by an auction sheet specifying the grade of the vehicle which shall not be below the grade of 3.5.
7. (1) Regulations 3, 4 and 5 shall be deemed to have come into operation on 1 January 2013.

(2) Regulation 6 shall come into operation on 1 March 2013.
