**ATT DWAR IS-SIGURTÀ TA' L-IKEL
(KAP. 449)****Regolamenti ta' l-2011 li jemendaw ir-Regolamenti dwar
Dolcifikanti għall-Użu f'Ogġetti ta' l-Ikel**

BIS-SAHHA tas-setgħat mogħtija bl-artikolu 10 ta' l-Att dwar is-Sigurtà ta' l-Ikel, il-Ministru għas-Saħħa, l-Anzjani u Kura fil-Kommunità għamel dawn ir-regolamenti li ġejjin:-

1. (1) It-titolu ta' dawn ir-regolamenti hu Regolamenti ta' l-2011 li jemendaw ir-Regolamenti dwar Dolcifikanti għall-Użu f'Ogġetti ta' l-Ikel, u għandhom jinqraw u jiftiehmha waħda mar-Regolamenti ta' l-2005 dwar Dolcifikanti għall-Użu f'Ogġetti ta' l-Ikel, hawn iżjed 'il quddiem imsejha "ir-regolamenti prinċipali".

Titolu u bidu fis-seħh.

A.L. 30 ta' l-2005.

(2) Dawn ir-regolamenti għandhom jitqiesu li dahhlu fis-seħh fil-31 ta' Marzu, 2011.

2. Regolamenti 3 u 4 jimplementaw il-provvedimenti tad-Direttiva tal-Kummissjoni 2010/37/UE tas-17 ta' Ġunju, li temenda d-Direttiva 2008/60/KE li tistabbilixxi l-kriterji speċifiċi tal-purità għas-sustanzi li jagħtu hlewwa għall-użu f'ogġetti ta' l-ikel.

Skop.

3. Minflok il-paragrafu (b) tar-regolament 1.3 tar-regolamenti prinċipali, għandu jidhol dan li ġejj:-

Jemenda r-regolament 1 tar-regolamenti prinċipali.

“(b) Direttiva tal-Kummissjoni 2008/60/KE li tistabbilixxi l-kriterji speċifiċi tal-purità għas-sustanzi li jagħtu hlewwa għall-użu f'ogġetti ta' l-ikel, kif emendata mid-Direttiva tal-Kummissjoni 2010/37/UE.”.

4. Fir-regolament 7.1 tar-regolamenti prinċipali, minflok il-kliem “Direttiva tal-Komunità Ewropa 95/31/KE, kif emendata”, għandu jidhol il-kliem “Direttiva tal-Kummissjoni 2008/60/KE, kif emendata bid-Direttiva tal-Kummissjoni 2010/37/UE.”.

Jemenda regolament 7 tar-regolamenti prinċipali.

(CAP. 449)****Sweeteners for Use in Foodstuffs (Amendment) Regulations,
2011**

IN exercise of the powers conferred by article 10 of the Food Safety Act, the Minister for Health, the Elderly and Community Care, has made the following regulations:-

Citation and commencement.

L.N. 30 of 2005.

1. (1) The title of these regulations is the Sweeteners for Use in Foodstuffs (Amendment) Regulations, 2011, and they shall be read and construed as one with the Sweeteners for Use in Foodstuffs Regulations, 2005, hereinafter referred to as “the principal regulations”.

(2) These regulations shall be deemed to have come into force on the 31st March 2011.

Scope.

2. Regulations 3 and 4 implement the provisions of Commission Directive 2010/37/EU of 17 June 2010 amending Directive 2008/60/EC laying down specific purity criteria on sweeteners for use in foodstuffs.

Amends regulation 1 of the principal regulations.

3. For paragraph (b) of regulation 1.3 of the principal regulations there shall be substituted the following:-

“(b) Commission Directive 2008/60/EC laying down specific purity criteria concerning sweeteners for use in foodstuffs as amended by Commission Directive 2010/37/EU.”.

Amends regulation 7 of the principal regulations.

4. In regulation 7.1 of the principal regulations, for the words “European Community Directive 95/31/EC, as amended”, there shall be substituted the words “Commission Directive 2008/60/EC, as amended by Commission Directive 2010/37/EU.”.
