L.N. 245 of 2011**ENVIRONMENT AND DEVELOPMENT PLANNING ACT
(CAP. 504)****Waste Management (Waste Batteries and Accumulators)
(Amendment) Regulations, 2011**

BY VIRTUE of the powers conferred by articles 2, 61, 64, and 66 of the Environment and Development Planning Act, the Prime Minister has made the following regulations:-

Title.

1. The title of these regulations is the Waste Management (Waste Batteries and Accumulators) (Amendment) Regulations, 2011, and they shall be read and construed as one with the Waste Management (Waste Batteries and Accumulators) Regulations, 2010, hereinafter referred to as “the principal regulations”.

Amends regulation
7 of the principal
regulations.

2. For sub-regulation (1) of regulation 7 of the principal regulations, there shall be substituted the following:

“(1) The Competent Authority shall calculate the collection rate for the first time in respect of the year 2011.”.
