**ENVIRONMENT AND DEVELOPMENT PLANNING ACT

**Conservation of Wild Birds (Declaration on a Derogation for a
2014 Autumn live-capturing season for Song Thrush and
Golden Plover) Regulations, 2014**

BY VIRTUE of the powers conferred by article 61 of the Environment and Development Planning Act, and in terms of the provisions of regulation 10(6)(t) of the Conservation of Wild Birds Regulations, and of regulations 4 and 7 of the Conservation of Wild Birds (Framework for Allowing a Derogation Opening an Autumn Live-Capturing Season for Song Thrush and Golden Plover) Regulations, the Minister for Sustainable Development, the Environment and Climate Change has made the following regulations:-

1. The title of these regulations is the Conservation of Wild Birds (Declaration on a Derogation for a 2014 Autumn live-capturing season for Song Thrush and Golden Plover) Regulations, 2014. Citation.

2. Terms and expressions used in these regulations, unless the context otherwise requires, shall have the same meaning as given to them in the Conservation of Wild Birds Regulations, hereinafter referred to as the "the Wild Birds Regulations", and in the Conservation of Wild Birds (Framework for Allowing a Derogation Opening an Autumn Live-Capturing Season for Song Thrush and Golden Plover) Regulations. 3. For the purposes of establishing the period for the live-capturing of wild birds under regulation 10(6)(i), (ii) and (iii) of the Wild Birds Regulations, and for the purpose of these regulations, the period for the live-capturing of Song Thrush and Golden Plover for the year 2014, hereinafter referred to as "the Autumn live-capturing season", shall be on the following dates: Establishing of periods.

(a) live-capturing of Song Thrush between the 20th October 2014 and the 31st December 2014, both dates included;

(b) live-capturing of Golden Plover between the 20th October 2014 and the 31st December 2014, both dates included.

4. For the purposes of these regulations, the Autumn live-capturing season shall be in accordance with the provisions of the Conservation of Wild Birds (Framework for Allowing a Derogation Opening an Autumn Live-Capturing Season for Song Thrush and Golden Plover) Regulations.

Quotas.

5. (1) The Autumn live-Capturing licence, which shall be issued upon the payment of a nominal fee of fifty-five euro (€55), shall set the overall seasonal bag limit for the Autumn live-capturing season at 5,000 for Song Thrush and 700 for Golden Plover as the total number of birds which may be captured under the authority of all issued licences taken together.

(2) The Autumn live-capturing licence shall set the live-capturing season's bag limit to six (6) birds for each Autumn live-capturing licence or however many below this number might have been captured before the season is closed.
