**FEES ORDINANCE  
(CAP. 35)**

**FISHERIES CONSERVATION AND MANAGEMENT ACT  
(CAP. 425)**

**Wholesale Fish Market Fees Regulations, 2021**

IN EXERCISE of the powers conferred by article 2 of the Fees Ordinance and article 38 of the Fisheries Conservation and Management Act, the Minister for Agriculture, Fisheries and Animal Rights, with the concurrence of the Minister for Finance and Financial Services, has made the following regulations:-

1. The title of these regulations is the Wholesale Fish Market Fees Regulations, 2021. Citation.
2. The fees and deductions provided for in these regulations shall apply and be payable in relation to services provided by the Government in accordance with the Fish Marketing Regulations at the wholesale fish market situated at Troubridge Street, Marsa. Scope.

3. (1) The fees payable to Government for the services referred to under regulation 2 or under the Fish Marketing Regulations shall be those as found in Schedule I to these regulations. Applicable fees and deductions.

- (2) Deductions made by Government are to be made in accordance with Schedule I from the amounts paid by retailers according to the Fish Marketing Regulations, and any remaining balances shall be due by Government to the fisherman according to the relevant sale.
4. The following consequential amendments shall be made: Consequential amendments.  
S.L. 425. 02.
  - (a) Sub-regulation (1) of regulation 18 of the Fish Marketing Regulations shall be substituted with the following:

"(1) When making payment in terms of regulation 17, the Director shall ensure that all fees and deductions according to the Wholesale Fish Market Fees Regulations are paid and made according to the same regulations."; and

(b) Regulations 21 and 31 of the Fish Marketing Regulations shall be deleted.

**SCHEDULE I**  
**Fees and deductions**

Regulation 3

<b>Service</b>	<b>Fee or deduction rate</b>	<b>Payable by or deduction from</b>
Fish crate use by a retailer	€0.15 (fifteen cents) fee for each fish crate	Retailer as defined under the Fish Marketing Regulations (S.L. 425.02).
Sale of fish by <i>pitkal</i>	A deduction of 5.3% from the amounts paid by a retailer for a first sale of caught fish at the wholesale fishmarket situated at Troubridge Street, Marsa.	Deducted by Government from the referred amounts and paid to the relevant <i>pitkal</i> .
Sale of fish by <i>pitkal</i>	A deduction of 1% from the amounts paid by a retailer for a first sale of caught fish made at the wholesale fishmarket situated at Troubridge Street, Marsa.	Deducted and retained by Government from the referred amounts as a service fee for the use of the wholesale fishmarket situated at Troubridge Street, Marsa.
