**MALTA RESOURCES AUTHORITY ACT  
(CAP. 423)**

**Notification of Groundwater Sources (Amendment) Regulations,  
2008**

IN exercise of the powers conferred by sub-article (1) of article 28 of the Malta Resources Authority Act, the Minister for Resources and Rural Affairs, after consultation with the Malta Resources Authority, has made the following regulations:–

Title and  
commencement.

L.N. 255 of 2008.

**1.** (1) The title of these regulations is the Notification of Groundwater Sources (Amendment) Regulations, 2008 and they shall be read and construed as one with the Notification of Groundwater Sources Regulations, 2008, hereunder referred to as “the principal regulations”.

(2) These regulations shall be deemed to have come into force on the 7<sup>th</sup> October, 2008.

Amends regulation  
3 of the principal  
regulations.

**2.** In sub-regulation (1) of regulation 3 of the principal regulations, for the words “until the 6<sup>th</sup> of November, 2008”, there shall be substituted the words “until the 20<sup>th</sup> November, 2008”.
