**Regolamenti ta' l-2009 li jemendaw ir-Regolamenti
dwar il-Konservazzjoni ta' l-Għasafar Selvaġġi**

BIS-SAHHA tas-setgħat mogħtija bl-artikoli 9 u 10 ta' l-Att dwar il-Ħarsien ta' l-Ambjent, il-Prim Ministru għamel dawn ir-regolamenti li ġejjin:-

1. (1) It-titolu ta' dawn ir-regolamenti hu Regolamenti ta' l-2009 li jemendaw ir-Regolamenti dwar il-Konservazzjoni ta' l-Għasafar Selvaġġi, u għandhom jinqraw u jinftiehmha waħda mar-Regolamenti ta' l-2006 dwar il-Konservazzjoni tal-Għasafar Selvaġġi, hawnhekk iżjed 'il quddiem imsejha "ir-regolamenti prinċipali".

Titolu.

2. Fir-regolament 24 tar-regolamenti prinċipali, minflok il-kliem "toroq prinċipali ta' santwarju ta' l-għasafar." għandhom jidhlu l-kliem "toroq prinċipali ta' santwarju ta' l-għasafar:" u minnufih wara dan għandu jidhol dan il-proviso ġdid li ġej:-

Jemenda r-regolament 24 tar-regolamenti prinċipali.

"Izda wkoll il-Ministru jista', skond id-dispożizzjonijiet tal-paragrafu (b) tas-subregolament (1) tar-regolament 9, b'avviż fil-Gazzetta, jawtorizza deroga mid-dispożizzjonijiet ta' dan ir-regolament dwar il-partiti (8) u (9) ta' l-Iskeda V li tinsab ma' dawn ir-regolamenti, fl-interess tas-sigurtà ta' l-ajru. F'każijiet ta' emerġenza, il-Ministru jista' joħroġ l-awtorizzazzjoni mingħajr ir-rakkomandazzjoni tal-Kumitat Ornis skond id-dispożizzjonijiet ta' dawn ir-regolamenti."

L.N. 30 of 2009**ENVIRONMENT PROTECTION ACT
(CAP. 435)****Conservation of Wild Birds (Amendment) Regulations, 2009**

BY VIRTUE of the powers conferred by article 9 and 10 of the Environment Protection Act, the Prime Minister has made the following regulations:–

Citation.

1. The title of these regulations is the Conservation of Wild Birds (Amendment) Regulations, 2007 and they shall be read and construed as one with the Conservation of Wild Birds Regulations, 2006, hereinafter referred to as “the principal regulations”.

L.N. 79 of 2006.

Amends regulation 24 of the principal regulations.

2. In regulation 24 of the principal regulations, for the words “main roads of a bird sanctuary.” there shall be substituted the words “main roads of a bird sanctuary:” and immediately thereafter there shall be added the following new proviso:–

“Provided further that the Minister may, in accordance with the provisions of paragraph (b) of sub-regulation (1) of regulation 9, by notice in the Gazette, authorize a derogation from the provisions of this regulation in respect to items (8) and (9) of Schedule V to these regulations, in the interests of air safety. In cases of urgency, the Minister may act without the recommendation of the Ornithology Committee in terms of these regulations.”.
