BIS-SAHHA tas-setgħat mogħtija bl-artikolu 9 ta' l-Att dwar il-Harsien ta' l-Ambjent, u skond id-disposizzjonijiet tar-regolament 10(6)(t) tar-Regolamenti ta' l-2006 dwar il-Konservazzjoni ta' l-Ghasafar Selvaġġi, il-Prim Ministru għamel dawn ir-regolamenti li ġejjin:-

1. (1) It-titolu ta' dawn ir-regolamenti huwa Regolamenti ta' l-2009 dwar il-Konservazzjoni ta' l-Ghasafar Selvaġġi (Dikjarazzjoni dwar l-Istaġun għall-Kaċċa u l-Insib għas-sena 2009). Titolu u bidu fis-sehħ.

(2) Dawn ir-regolamenti għandhom jitqiesu li bdew isehħu fil-31 ta' Lulju, 2009.

2. Kliem u frazijiet użati f' dawn ir-regolamenti, kemm-il darba r-rabta tal-kliem ma tkunx teħtieġ xort'oħra, għandu jkollhom l-istess tifsira bħal dak mogħti fir-Regolamenti ta' l-2006 dwar il-Konservazzjoni ta' l-Ghasafar Selvaġġi, hawnhekk iżjed 'il quddiem imsejhin "ir-Regolamenti ta' l-2006". Tifsir.

3. Għall-finijiet li jstabbilixxi l-istaġun għall-kaċċa u l-insib ta' l-għasafar taħt ir-regolament 10 (6)(t), (ii) u (iii) tar-Regolamenti ta' l-2006, il-Ministru stabbilixxa:- Jigi stabbilit l-Istaġun.

(a) kaċċa minn fuq l-art għandha ssir bejn l-1 ta' Settembru 2009 u l-31 ta' Jannar 2010, bejn sagħtejn qabel tluġh ix-xemx u sagħtejn wara nżul ix-xemx fil-granet mit-Tnejn sas-Sibt, u bejn sagħtejn qabel tluġh ix-xemx u s-siegħa ta' wara nofsinhar (1.00p.m.) fil-Hdud u l-Festi Pubbliċi:

Iżda, kaċċa minn fuq l-art bejn il-15 ta' Settembru 2009 u t-30 ta' Settembru 2009, ma tistax issir mit-Tnejn sas-Sibt wara l-ħin tat-3.00 ta' wara nofsinhar (3.00pm);

(b) kaċċa minn fuq il-baħar għandha ssir bejn l-1 ta' Ottubru 2009 u l-31 ta' Jannar 2010;

(ċ) teħid ta' Gamiem u Summien għandu jsir bejn l-1 ta' Settembru 2009 u l-30 ta' Ottubru 2009.

(d) teħid ta' Pluviera u Malvizz għandu jsir bejn l-20 ta' Ottubru 2009 u l-10 ta' Jannar 2010.

4. Il-ħinijiet li japplikaw għat-teħid u l-kaċċa tal-fenek selvaġġ bejn il-15 ta' Settembru 2009 u t-30 ta' Settembru 2009, għandhom ikunu dawk stabbiliti fil-proviso tal-paragrafu (a) tar-regolamenti 3 ta' dawn ir-regolamenti.

**ENVIRONMENT PROTECTION ACT
(CAP. 435)**

**Conservation of Wild Birds (Declaration of the periods for
Hunting and Taking for 2009) Regulations, 2009**

BY VIRTUE of the powers conferred by article 9 of the Environment Protection Act, and in terms of the provisions of regulation 10(6)(t) of the Conservation of Wild Birds' Regulations, 2006, the Prime Minister has made the following regulations :-

1. (1) The title of these regulations is the Conservation of Wild Birds (Declaration of the periods for Hunting and Taking for 2009) Regulations, 2009. Citation and commencement.

(2) These regulations shall be deemed to have come into force on the 31st July, 2009.

2. Terms and expressions used in these regulations, unless the context otherwise requires, shall have the same meaning as given to them in the Conservation of Wild Birds Regulations, 2006, hereinafter referred to as the "2006 Regulations". Interpretation.

3. For the purposes of establishing the period for the hunting and taking of wild birds under paragraphs (i), (ii) and (iii) of sub-regulation (6) of regulation 10 of the 2006 Regulations, the Minister has established the following dates:- Establishing of periods.

(a) the hunting of birds on land shall be permitted between the 1st September 2009 and the 31st January 2010, between two hours before sunrise and two hours after sunset on any day between Monday and Saturday, and between two hours before sunrise and 1 o'clock in the afternoon (1.00 p.m) on Sundays and Public Holidays:

Provided that hunting on land between the 15th September 2009 and the 30th September 2009 shall not be permitted from Monday to Saturday after 3.00 pm and two hours before sunrise of the next following day.

(b) the hunting of birds at sea shall be permitted between the 1st October 2009 and the 31st January 2010;

(c) taking of Turtle Dove and Quail between the 1st September 2009 and the 30th October 2009; and

(d) taking of Golden Plover and Song Thrush between the 20th October 2009 and 10th January 2010.

4. The applicable times for the taking and shooting of wild rabbits between the 15th September 2009 and the 30th September 2009 shall be as established in the proviso to paragraph (a) of regulation 3 of these regulations.

5. The Conservation of Wild Birds (Declaration of the periods for Hunting and Taking for 2009) Regulations, 2009 are hereby being repealed.
