A.L. 250 tal-2009**ATT DWAR L-AWTORITÀ MARITTIMA TA' MALTA  
(KAP. 352)****Regolamenti tal-2009 li jemendaw ir-Regolamenti dwar  
Bastimenti Żgħar**

BIS-SAHHA tas-setgħat mogħtija bl-artikoli 29(3) u 52 tal-Att dwar l-Awtorità Marittima ta' Malta, il-Ministru għall-Infrastruttura, Trasport u Kommunikazzjoni, b'konsultazzjoni mal-Awtorità Marittima ta' Malta, għamel dawn ir-regolamenti li ġejjin:

**1.** (1) It-titolu ta' dawn ir-regolamenti hu r-Regolamenti tal-2009 li jemendaw ir-Regolamenti dwar Bastimenti Żgħar, u għandhom jinqraw u jiftiehm u haġa waħda mar-Regolamenti tal-2008 dwar Bastimenti Żgħar, hawn iżjed 'il quddiem f'dawn ir-regolamenti msejnin "ir-regolamenti prinċipali".

Titolu u bidu fis-sehħ.

A.L. 183 tal-2008.

(2) Dawn ir-regolamenti għandhom jitqiesu li bdew isehħu fl-1 ta' Lulju, 2009.

**2.** Minnufih wara s-subregolament (3) tar-regolament 3 tar-regolamenti prinċipali għandu jidhol dan is-subregolament ġdid li ġej:

Jemenda r-regolament 3 tar-regolamenti prinċipali.

"(4) Il-bastimenti żgħar li ġejjin, li huma għall-użu personali biss u ma jintużawx b'mod kummerċjali, huma eżentati mir-registrazzjoni taħt dan ir-regolament:

(a) kenuri; u

(b) *dinghies* bla kabina, bil-qluġh u mingħajr magni, ta' mhux iżjed mit-tul totali ta' 5.2 metri."

## Small Ships (Amendment) Regulations, 2009

IN exercise of the powers conferred by articles 29(3) and 52 of the Malta Maritime Authority Act, the Minister for Infrastructure, Transport and Communications, in consultation with the Malta Maritime Authority, has made the following regulations:

Citation and  
commencement.

**1.** (1) The title of these regulations is the Small Ships (Amendment) Regulations, 2009 and they shall be read and construed as one with the Small Ships Regulations, 2008, hereinafter referred to as “the principal regulations”.

(2) These regulations shall be deemed to have come into force on the 1st July, 2009.

Amends regulation  
3 of the principal  
regulations.

**2.** Immediately after sub-regulation (3) of regulation 3 of the principal regulations, there shall be added the following new sub-regulation:

“(4) The following small ships, which are for personal use only and not used in a commercial manner, are exempted from registration under this regulation:

- (a) canoes; and
- (b) open sailing dinghies, without engines, not exceeding 5.2 metres in length overall.”.
