**MALTA VETERINARY SERVICES ACT
(CAP. 437)****Health Conditions governing Intra-Community Trade in Ovine
and Caprine Animals (Amendment) Rules, 2010**

IN EXERCISE of the powers conferred by articles 8 and 9 of the Veterinary Services Act, the Minister for Resources and Rural Affairs has made the following rules:-

Title.

1. The title of these rules is the Health Conditions governing Intra-Community Trade in Ovine and Caprine Animals (Amendment) Rules, 2010 and they shall be read and construed as one with the Health Conditions governing Intra-Community Trade in Ovine and Caprine Animals Rules, 2005 hereinafter referred to as “the principal rules”.

2. For rule 8 of the principal rules, there shall be substituted the following:-

“8. (1) The competent Authority shall issue an approval number to each approved assembly centre. Approvals may be limited to one or more species covered by these rules or to animals for breeding or fattening, or to animals for slaughter. The competent Authority shall draw up and keep up to date a list of approved assembly centres and their unique approval numbers and make it available to the other Member States and to the public.

(2) The competent Authority shall draw up and keep up to date a list of approved dealers and registered premises used by dealers in connection with their business and their approval numbers and shall make it available to the other Member States and to the public. Detailed rules for the uniform application of this sub-rule may be adopted in accordance with the procedure referred to in rule 15(2) of these rules.”.
