An Act to amend The Watershed Conservation Districts Act.

---

[Assented to April 15th, 1961]

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Manitoba, enacts as follows:

Cl. (k1) of sec.  
2 added.

**1.** Section 2 of The Watershed Conservation Districts Act, being chapter 70 of the Statutes of Manitoba, 1959 (Second Session), is amended by adding thereto, immediately after clause (k) thereof, the following clause:

"rateable  
land"

(k1) "rateable land" means land liable to taxation by a municipality but does not include any improvements, buildings, erections, structures, or fixtures, built, erected, constructed, fixed or placed on the land.

**2.** Subsection (2) of section 6 of the Act is amended

(a) by adding thereto, immediately after the word "comprise" in the first line thereof, the word "rateable";

(b) by striking out the word "equalized" in the second line thereof;

(c) by striking out the word "equalized" in the third line thereof;

and

(d) by adding thereto, immediately after the word "the" where it appears for the third time in the third line thereof, the word "rateable".

sec. 17 amended.

**3.** Subsection (2) of section 17 of the Act is amended

(a) by striking out the word "ten" in the second line of clause (b) thereof and substituting therefor the word "five";

(b) by striking out the word "equalized" in the seventh line thereof;

and

(c) by striking out the word "property" in the eighth line thereof and substituting therefor the word "land".

sec. 17 amended.

**4.** Subsection (4) of section 17 of the Act is amended

(a) by striking out the word "equalized" in the third line thereof;

and

(b) by striking out the word "property" in the fourth line thereof and substituting therefor the word "land".

Subsecs. (6), (7), and (8) of sec. 17 repealed and substituted.

**5.** Subsections (6), (7), and (8) of section 17 of the Act are repealed and the following subsections are substituted therefor:

Levy of taxes.

(6) Subject to subsection (2) of section 21, the board shall, not later than the last day of February in each year, forward to each included municipality a statement of the amount apportioned to it in respect of that year; and the statement shall be in such form and contain such particulars as may be prescribed in the regulations; and the municipality shall thereupon levy and collect as a special rate, a tax on the assessed value

(a) of the rateable land; or

(b) of the land as defined in clause (f) of section 983 of The Municipal Act;

within the included area for the purpose of making payment to the board of the amount apportioned to it.

Payment of amount apportioned.

(7) Except in the case of a local government district, each included municipality shall, after making a levy under subsection (6) in any year, pay to the board

(a) on or before the thirty-first day of August in that year an amount that is not less than twenty-five per centum of the amount apportioned to it;

(b) on or before the thirty-first day of October in that year an amount that together with the amount paid under clause (a) amounts to not less than eighty-five per centum of the amount apportioned to it; and

(c) on or before the thirty-first day of December in that year the balance of the amount apportioned to it.

Payment of apportionment by local govt. dist.

(8) Each local government district within the included area shall, after making a levy under subsection (6) in any year, pay to the board on or before the tenth day of each month the amount of the levy collected in the next preceding month.

Special levy on part of municipality to cover deficit.

(9) Where an included area does not comprise the whole of a municipality, if in any year the amount col-

lected under subsection (6) or under this subsection is not sufficient to pay the amount apportioned to the municipality in respect of the included area, and those amounts have been paid by the municipality from its general funds, the municipality may, in any subsequent year, levy and collect as an additional special rate, a tax

(a) on the rateable lands; or

(b) on the lands as defined in clause (f) of section 983 of The Municipal Act;

within the included area for the purpose of reimbursing its general funds the amount of the deficiency paid therefrom as aforesaid.

**6.** Subsection (1) of section 18 of the Act is amended

(a) by striking out the word "equalized" in the eleventh line thereof;

and

(b) by striking out the word "property" in the twelfth line thereof and substituting therefor the word "land".

Subsec. (2) of sec. 18 amended.

**7.** Subsection (2) of section 18 of the Act is amended

(a) by striking out the word "equalized" where it appears in the fifth, eighth, and tenth lines thereof;

and

(b) by striking out the word "property" in the sixth, ninth, and eleventh lines thereof and substituting therefor, in each case, the word "land".

Subsec. (3) of sec. 18 amended.

**8.** Subsection (3) of section 18 of the Act is amended

(a) by striking out the word "equalized" in the sixth line thereof;

and

(b) by striking out the word "property" in the seventh line thereof and substituting therefor the word "land".

Sec. 19 amended.

**9.** Section 19 of the Act is amended

(a) by striking out the word "equalized" in the fourth line thereof;

and

(b) by striking out the word "property" in the fourth line thereof and substituting therefor the word "land".

Commence-  
ment of Act.

**10.** This Act comes into force on the day it receives the royal assent.
