ENACTED by the National Assembly of the Federal Republic of Nigeria-

1. The Small and Medium Scale industries Development Agency Act No. 16, 2003 (in this Act referred to as "the Principal Act") is amended as set out in this Act. Amendment of Act No. 16, 2003
2. Section 25 (2) of the Principal Act is amended by substituting for – Amendment of section 25
 - (a) the expression, "N50,000", in line 3, the expression, "N500,000"; and
 - (b) the words, "not exceeding", in line 3, the word, "of".
3. This Act may be cited as the Small and Medium Scale Industries Development Agency (Amendment) Act, 2016. Citation
