AN ACT TO AMEND THE AGRICULTURAL CREDIT GUARANTEE SCHEME FUND ACT CAP. A11, LAWS OF THE FEDERATION OF NIGERIA, 2004 TO ENHANCE THE CAPITAL BASE, EXPAND THE COVERAGE OF THE SCHEME, INCREASE THE SIZE OF THE LOANABLE FUND, INCREASE MEMBERSHIP AND GIVE MORE POWERS TO THE BOARD ; AND FOR RELATED MATTERS.

ENACTED by the National Assembly of the Federal Republic of Nigeria—

1. The Agricultural Credit Guarantee Scheme Fund Act Cap. A11, Laws of the Federation of Nigeria, 2004 (in this Act referred to as “the Principal Act”) is amended as set out in this Act. Amendment
of Cap. A11.
LFN. 2004.

2. Section 2 (2) of the Principal Act is amended by substituting for paragraph (a), a new paragraph “(a)”— Amendment
of section 2.

“(a) the Minister shall appoint—

- (i) a chairman,
- (ii) a representative of the Nigerian Farmers,
- (iii) a representative of the Federal Ministry of Finance, and
- (iv) a representative of the Federal Ministry of Agriculture.”

3. Section 5 of the Principal Act is amended by—

(a) substituting for the words, “one hundred million Naira”, in line 1, the words, “fifty billion Naira”;

(b) inserting a new subsection “(2)”—

“(2) The fund of fifty billion Naira may be increased by such amount as the Board may determine and that amount shall be contributed in a proportion as the Board may prescribe” ; and

(c) renumbering the section appropriately.

4. Section 6 (1) of the Principal Act is amended—

(a) in paragraph (a), by substituting for the expression, “N100,000”, in line 1, the expression, “N50,000,000” ; and

(b) by deleting paragraph (b).

5. Sections 7 (1) – 9, 14 (1), 16 (1) and 19 (1) of the Principal Act are amended by substituting for the word, “Minister”, the word, “Board”.

6. Section 10 (2) of the Principal Act is amended by substituting for the expression, “N5,000”, in line 2, the expression, “N100,000”.

7. Paragraph 1 of the Schedule to the Principal Act is amended—
(a) in subparagraph (a), by inserting after the word, “cofee”, the word, “tea” ;
(b) in subparagraph (d), by inserting after the word, “machinery”, the word, “purchase” ; and
(c) by inserting new subparagraphs “(e)” and “(f)”—
“*(e)* production of farm machinery, implements and equipment for production, processing, storage and transportation ; and
“*(f)* any purpose connected with the activities within the agricultural value chain”.

8. This Act may be cited as the Agricultural Credit Guarantee Scheme Fund (Amendment) Act, 2019.
