Commencement

ENACTED by the National Assembly of the Federal Republic of Nigeria-

1. The National Biosafety Management Agency Act No. 20, 2015 (in this Act referred to as "the Principal Act") is amended as set out in this Act.

2. Section 3 of the Principal Act is amended by -

- (a) inserting after paragraph (j) a new "paragraph (Ja)" -
 - "(Ja) put in place measures to ensure Bio-Security;" and
- (b) re-numbering the paragraphs appropriately.
- 3. Insert, after section 25 of the Principal Act, a new section "25A" -

Insertion of new section 25A.

"Application of gene drive, gene editing and synthetic biology. 25A. A person, institution or body shall not carryout gene drive, gene editing and synthetic biology except with the approval of the Agency."

4. Section 43 of the Principal Act is amended by inserting the following definitions in Amendment of section alphabetical order -

"Biosecurity" includes measures to prevent, respond to and recover harmful biological substances or genetically modified organisms that may threaten the health of humans, animals, environment and the economy;

"gene drive" means a genetic engineering technology that can propagate a particular suite of genes throughout a population by adding, deleting, disrupting or modifying genes, which can only spread from sexually reproducing parents to their offspring:

gene editing" means a type of genetic engineering in which DNA is inserted, deleted, modified or replaced in the genome of a living organism;

- "Synthetic biology" means the design and construction of novel artificial biological pathways, organisms or devices, or the redesign of existing natural biological systems."
- 5. This Act may be cited as the National Biosafety Management Agency (Amendment) Citation. Act, 2019.
