POUNDS REGULATIONS

Regulations under the *Pounds Act*

1 Citation

These Regulations may be cited as the *Pounds Regulations*.

2 Poundage fees

The poundage fees payable in relation to impounded cattle (other than sucklings under the age of 6 months) are set out in the Schedule.

3 Repeal

The *Pounds Regulations*, Regulations 1967, No. 27, are repealed.

| For an entire horse, mule, ass, camel, bull or boar over or apparently over the age of 2 years | 20.00 | 5.00 |
| For an entire horse, mule, ass, camel, bull or boar under or apparently under the age of 2 years | 15.00 | 2.50 |
| For a mare, gelding, colt, filly, foal, ox, cow, steer, heifer, calf, ram or pig (other than a boar) | 10.00 | 2.50 |
| For a wether, ewe, lamb or goat | 5.00 | 1.25 |

*Note: **cattle** is defined in section 3 of the Act and includes an entire horse, mare, gelding, colt, filly or foal, bull, cow, ox, steer, heifer or calf, sheep, camel, ass, mule, goat, pig or buffalo.
