### **Notice**

#### **1 Title**

This notice is the Fisheries (Notification of Tāngata Kaitiaki/Tiaki for Area/Rohe Moana of Ngā Kaitiaki o Te Puaha—Te Awamaarahi Marae) Notice 2017.

#### **2 Commencement**

This notice comes into force on the day after the date of its notification in the *Gazette*.

#### **3 Customary food gathering area/rohe moana**

This notice applies to the customary food gathering area/rohe moana defined by clause 2(d) of the Fisheries (Kaimoana Customary Fishing) Notice (No. 10) 2007 (*Gazette* 2007, p 3373), which is an area from Okarahia, at the mouth of the Waikato River, to Ngatutura Point.

**4 Tangata whenua**

The tangata whenua of the area/rohe moana are Ngā Kaitiaki o Te Puaha.

**5 Appointment cancelled**

- (1) The Minister for Primary Industries has cancelled the appointment of George Hori Te Kanawa Katipa as a Tangata Kaitiaki/Tiaki for the area/rohe moana.
- (2) The cancellation took effect at the end of 30 April 2017.

**6 New appointment**

- (1) The Minister for Primary Industries has appointed Hero Potini as a Tangata Kaitiaki/Tiaki for the area/rohe moana.
- (2) The appointment took effect on 1 May 2017.

**Explanatory note**

*This note is not part of the notice, but is intended to indicate its general effect.*

This notice is made under the Fisheries (Kaimoana Customary Fishing) Regulations 1998 (the **regulations**). It comes into force on the day after the date of its notification in the *Gazette*.

This notice relates to a customary food gathering area/rohe moana of the Ngā Kaitiaki o Te Puaha represented by Te Awamaarahi Marae. The area/rohe moana is an area from Okarahia, at the mouth of the Waikato River, to Ngatutura Point.

Notice is given of the cancellation of the appointment of a Tangata Kaitiaki/Tiaki for the area/rohe moana and the appointment of a replacement. The Minister for Primary Industries cancelled the appointment and made the replacement appointment at the request of Te Awamaarahi Marae.

The powers of Tāngata Kaitiaki/Tiaki are set out in the regulations.
