#### 1 Title

This notice is the Fisheries (Notification of Mātaimai Reserve at Tauparikaka and Tāngata Tiaki/Kaitiaki) Amendment Notice 2016.

#### 2 Commencement

This notice comes into force on the day after the date of its notification in the *Gazette*.

#### 3 Principal notice

This notice amends the notice that was previously called the Fisheries (Declaration and Notification of Tauperikaka Mātaimai Reserve and Appointment of Tangata Tiaki/Kaitiaki) Notice 2011 (*Gazette* 2011, p 3818) (**the principal notice**).

#### 4 Name of principal notice changed

(1) As from the commencement of this notice,—

- (b) every reference in any enactment and in any document to the Fisheries (Declaration and Notification of Tauperikaka Mātaimai Reserve and Appointment of Tangata Tiaki/Kaitiaki) Notice 2011 must, unless the context otherwise provides, be read as a reference to the Fisheries (Notification of Mātaimai Reserve at Tauparikaka and Tāngata Tiaki/Kaitiaki) Notice 2011.
- (2) In clause 1, replace “Fisheries (Declaration and Notification of Tauperikaka Mātaimai Reserve and Appointment of Tangata Tiaki/Kaitiaki) Notice 2011” with “Fisheries (Notification of Mātaimai Reserve at Tauparikaka and Tāngata Tiaki/Kaitiaki) Notice 2011”.

### **Explanatory note**

*This note is not part of the notice, but is intended to indicate its general effect.*

This notice, which comes into force on the day after the date of its notification in the *Gazette*, amends the name of the notice that was previously called the Fisheries (Declaration and Notification of Tauperikaka Mātaimai Reserve and Appointment of Tangata Tiaki/Kaitiaki) Notice 2011 (*Gazette* 2011, p 3818). The amended name refers to the mātaimai reserve at Tauparikaka, rather than Tauperikaka. This amendment reflects the name traditionally used for the area in which the mātaimai reserve is located.
