Regulations

1 Title and commencement

- (1) These regulations may be cited as the Fisheries (South-East Area Amateur Fishing) Regulations 1986.
- (2) These regulations shall come into force on the 14th day after the date of their notification in the *Gazette*.

2 Application

These regulations apply in respect of all persons taking or possessing any fish to which these regulations relate, other than commercial fishers taking or possessing fish under a permit, licence, quota, or other authorisation issued or granted under the Act or any regulations made under the Act.

3 Interpretation

In these regulations, unless the context otherwise requires,—
Act, means the Fisheries Act 1983 or the Fisheries Act 1996
Akaroa Harbour taiapure means the area described in the Schedule of the Fisheries (Akaroa Harbour Taiapure) Order 2006

barracouta means a fish of the species *Thyrsites atun*

blue cod means a fish of the species *Parapercis colias*

blue moki means a fish of the species *Latridopsis ciliaris*

bluenose means a fish of the species *Hyperoglyphe antarctica*

blue shark means a fish of the species *Prionace glauca*

bronze shark means a fish of the species *Carcharhinus brachyurus*

butterfish means a fish of the species *Odax pullus* or *Odax cyanoallix*

cat's eye means the shellfish of the species *Turbo smaragdus*

Chatham Islands rock lobster fishery means the rock lobster fishery within all that area of New Zealand fisheries waters enclosed by a line commencing at the point 40° 25'S and 178°W on the outer limits of the exclusive economic zone, then pro-

ceeding along the outer limits of the zone to the point 51° 50'S and 174° 35'E, then proceeding in a straight line to the point 50° 55'S and 173° 50'E, then proceeding along the outer limits of the zone to the point 48° 15'S and 174°E, then proceeding in a straight line to the point of commencement

cockle means the mollusc *Chione (Austrovenus) stutchburyi*:

East Otago taiapure means the area described in the Schedule of the Fisheries (East Otago Taiapure) Order 1999

eel means the shortfin eel (*Anguilla australis*) and the longfin eel (*Anguilla dieffenbachii*)

elephant fish means a fish of the species *Callorhynchus milii*

flatfish means a fish of the species—

- (a) sand flounder (“dab”, “white”, or “square” flounder) (*Rhombosolea plebeia*); or
- (b) lemon sole (*Pelotretis flavilatus*); or
- (c) New Zealand sole (*Peltorhampus novazeelandiae*); or
- (d) flounder (yellow belly) (*Rhombosolea leporina*); or
- (e) black flounder (*Rhombosolea retiaria*); or
- (f) greenback flounder (*Rhombosolea tapirina*); or
- (g) brill (*Colistium guntheri*); or
- (h) turbot (*Colistium nudipinnis*)

fyke net means any trap net (set with or without leaders or wings) with the trap section having single or multiple throats and supported by hoops or rings with the leaders or the net being held in position by poles or anchoring devices or by both poles and anchoring devices

grey mullet means a fish of the species *Mugil cephalus*

hammerhead shark means a fish of the species *Sphyrna zygaena*

hapuku bass means a fish of the species *Polyprion oxygeneios* or *Polyprion moene*

herring means the yellow-eyed mullet (*Aldrichetta forsteri*); but does not include the sardine (*Sardinops neopilchardus*) or the species of mullet known as *Mugil cephalus* or kanae

kahawai means a fish of the species *Arripis trutta*

Kaikoura-North Canterbury Area means all that area of New Zealand fisheries waters enclosed by a line commencing at a point 42°10.0'S and 176° 00.0'E; then proceeding south

along the 176° 00.0'E line of longitude to latitude 43° 23.62'S; then proceeding west along the 43° 23.62'S line of latitude to the mean high-water mark of the east coast of the South Island (approximately 172° 42.43'E, near the south bank of the Waimakariri River); then proceeding in a generally north-east-erly direction along the mean high-water mark of the South Island to latitude 42° 10.0'S (approximately 173° 56.5'E, near Clarence Point); then proceeding east along the 42° 10.0'S line of latitude until reaching the point of commencement

kingfish means a fish of the species *Seriola lalandi* (formerly known as *Seriola grandis*)

lamprey means a fish of the species *Geotria australis*

ling means a fish of the species *Genypterus blacodes*

mako shark means a fish of the species *Isurus oxyrinchus*

Maori has the same meaning as in the Maori Affairs Act 1953.

marblefish means a fish of the species *Aplodactylus etheridgi* or *Aplodactylus arcticdens*

marlin means a fish of the species *Tetrapturus audax*, *Makaira nigricans*, or *Makaira indica*

Onawe Peninsula marine area means the area described in the Schedule

porbeagle shark means a fish of the species *Lamna nasus*

red cod means a fish of the species *Pseudophycis bacchus*

red coral means a coelenterate of the order stylasterina

red gurnard means a fish of the species *Chelidonichthys kumu*

red moki means a fish of the species *Chelidonichthys spectabilis*

rig means a fish of the species *Mustelus lenticulatus*

rock lobster means the fish whose scientific name is *Jasus edwardsii*, commonly known as the spiny or red rock lobster

school shark means a fish of the species *Galeorhinus australis*

sea horse means a fish of the genus *Hippocampus*

sea perch or **Jock Stewart** means a fish of the genus *Helicolenus*

set net includes a gill net or any other sort of net that acts by enmeshing, entrapping, or entangling any fish

seven gilled shark means a fish of the species *Notorhynchus cepedianus* or *Heptranchias perlo*

skate ray means a fish of the Order *Rajiformes*

South-East Fishery Management Area means the fishery management area described as the South-East Fishery Management Area in the Schedule to the notice declaring fishery management areas that was published in the *Gazette* on the 5th day of February 1986 at page 412

spiky dog means a fish of the species *Squalus acanthias*

snapper means a fish of the species *Chrysophrys auratus*

stargazer means a fish of the species *Kathetostoma giganteum*

tarakihi means a fish of the species *Nemadactylus macropterus*

thresher shark means a fish of the species *Alopias vulpinus*

trevally means a fish of the species *Caranx georgianus*

trumpeter means a fish of the species *Latris lineata*

(3A) No person may, on any day,—	
(a) take from the Kaikoura-North Canterbury Area more than 10 blue cod; or

(4) No person may, on any day,—	
(a) take from within the South-East Fishery Management Area a total quantity of hapuku/bass and kingfish exceeding 5; or	
(b) possess a total quantity of hapuku/bass and kingfish exceeding 5 in that area; or	
(c) possess a total quantity of hapuku/bass and kingfish exceeding 5 taken from within that area.	
(5) No person may, on any day,—	
(a) take from within the South-East Fishery Management Area more than 3 kingfish; or	
(b) possess more than 3 kingfish in that area; or	

- (c) possess more than 3 kingfish taken from within that area.
- (6) A person contravenes this subclause if the person, on any day, takes or possesses more than the daily limit of fish (as specified in this regulation), but not more than 3 times the daily limit.
- (7) A person contravenes this subclause if the person, on any day, takes or possesses more than 3 times the daily limit of fish (as specified in this regulation).

3AB East Otago taiapure: maximum daily number of finfish

- (1) No person may, on any day,—
- (a) take more than 10 finfish from the southern part of the East Otago taiapure; or
 - (b) possess more than 10 finfish in the southern part of the East Otago taiapure; or
 - (c) possess more than 10 finfish taken from the southern part of the East Otago taiapure.
- (2) A person contravenes this subclause if the person, on any day, takes or possesses more than the maximum daily number of

finfish specified in subclause (1), but not more than 3 times the maximum daily number.

- (3) A person contravenes this subclause if the person, on any day, takes or possesses more than 3 times the maximum daily number of finfish.
- (4) In this regulation, **southern part of the East Otago taiapure** means the area—
- (a) commencing at the easternmost point of Huriawa Peninsula (at 45°38.40'S and 170°40.47'E); and
 - (b) then proceeding due east to a point (at 45°38.40'S and 170°40.69'E); and
 - (c) then proceeding south-west to Brinns Point (at 45°40.32'S and 170°39.18'E); and
 - (d) then proceeding south-west to a point on Warrington Spit (at 45°43.73'S and 170°36.00'E); and
 - (e) then proceeding south-east to Potato Point (at 45°44.42'S and 170°38.30'E); and

 - (d) *inner Pigeon Bay*: that part of Pigeon Bay lying within a straight line drawn between a westerly point (at 43°40.13'S and 172°53.39'E) and an easterly point (at 43°40.18'S and 172°54.33'E).

(3) **Flatfish set net** means a net that—

- (a) is equal to or less than 9 meshes deep; and
- (b) has a monofilament diameter equal to or less than 0.35 mm; and
- (c) has a mesh size equal to or greater than 100 mm; and
- (d) is anchored at each end; and
- (e) does not exceed a total length of 60 m.

7 Ngai Tahu eel fishery at Lake Forsyth

- (1) No person who does not belong to the Ngai Tahu iwi may take any eels from Lake Forsyth.
- (2) For the purposes of this regulation the term **Ngai Tahu iwi** means the collective of those individuals who descend from the primary hapu of Ngai Tahu and Ngati Mamoe, namely, Kati Kuri, Kati Irakehu, Kati Huirapa, Ngai Tuahuriri, and Kai Te Ruahikihiki.

7B Seasonal restriction on taking rock lobster from Chatham Islands

- (1) No person may—
 - (a) take any rock lobster from the waters of the Chatham Islands rock lobster fishery during the months of March and April in any year; or
 - (b) fish using any rock lobster pot in those waters during those months; or
 - (c) be in possession of any rock lobster that is taken from those waters during those months.
- (2) A person contravenes this subclause if the person, in taking or being in possession of rock lobsters in breach of subclause (1), takes or is in possession of not more than 6 rock lobsters.
- (3) A person contravenes this subclause if the person, in taking or being in possession of rock lobsters in breach of subclause (1), takes or is in possession of more than 6 rock lobsters.

7C Handgathering of dredge oysters

- (1) Despite regulations 19 and 23 of the Fisheries (Amateur Fishing) Regulations 1986, any person may take dredge oysters from the waters of the South-East (Coast) Fishery Management Area (excluding the waters surrounding the Chatham Islands) at any time by the method of handgathering, without limit as to size or season, and may possess any dredge oysters so taken.
- (2) In this regulation, **dredge oyster** means a shellfish of the species *Tiostrea chilensis*.

8 Offences and penalties

- (1) A person commits an offence and is liable on summary conviction to a fine not exceeding \$10,000 if the person contravenes, or fails to comply with, any of regulations 3A(6), 3AB(2), 3B to 6B, 6C(4), 6D, 6DA, 6DB(2), 6DC(2), 6DD(2), 6DE, 6F to 7, or 7B(1)(b) or (2).
- (2) A person commits a serious non-commercial offence and is liable on summary conviction to a fine not exceeding \$20,000 if the person contravenes, or fails to comply with any of regulations 3A(7), 3AB(3), 6C(5), 6DB(3), 6DC(3), 6DD(3), 6E, or 7B(3).
- (3) It is a defence to a charge of possessing more than the specified maximum daily number of any fish in contravention of these regulations if the defendant satisfies the court that the number of fish possessed in excess of the relevant specified daily number were not taken in breach of the regulations.

- (b) proceeding in a north-easterly direction for 50 m to a point at 43°45.78'S and 172°55.67'E; then
- (c) proceeding south and then north along a line every point of which is 50 m from the mean high-water springs mark of Onawe Peninsula to a point 50 m off the coast on the western side of the peninsula at 43°45.82'S and 172°55.54'E; then
- (d) proceeding in a north-easterly direction for 50 m to a point south-west of the most southern point of Onawe Flat Road on the western coast of Onawe Peninsula at 43°45.80'S and 172°55.58'E.
