Amendments to Schedule 1

Regulations

1 Title

These regulations are the Fisheries (Infringement Offences) Amendment Regulations (No 2) 2008.

2 Commencement

These regulations come into force on 1 October 2008.

3 Principal regulations amended

These regulations amend the Fisheries (Infringement Offences) Regulations 2001.

4 Schedule 1 amended

(1) Schedule 1 is amended by inserting the items set out in Part 1 of the Schedule of these regulations after the item relating to regulation 2C under the heading “Fisheries (Challenger Area Amateur Fishing) Regulations 1986 (SR 1986/224)”.

(2) Schedule 1 is amended by inserting the item set out in Part 2 of the Schedule of these regulations after the item relating to regulation 4A under the heading “Fisheries (Challenger Area Amateur Fishing) Regulations 1986 (SR 1986/224)”.

(3) Schedule 1 is amended by adding the item set out in Part 3 of the Schedule of these regulations under the heading “Fisheries (Challenger Area Amateur Fishing) Regulations 1986 (SR 1986/224)”.

(4) Schedule 1 is amended by inserting the item set out in Part 4 of the Schedule of these regulations after the item relating to regulation 6E under the heading “Fisheries (South-East Area Amateur Fishing) Regulations 1986 (SR 1986/225)”.

Schedule Amendments to Schedule 1

Part 1

2D Taking from or possessing in the Challenger (East) Area undersized blue cod 250
2E Landing blue cod otherwise than in a whole or gutted state 500

Part 2

4AC Using a set net in the waters described in r 4AC(2), other than a flatfish set net during the period commencing on 1 April in each year and ending on 30 September in that year 500

Part 3

4F(2) Taking or possessing up to 3 blue cod taken from within the enclosed waters of the Marlborough Sounds on any day during the period commencing on 1 October 2008 and ending on 1 October 2012 500

Part 4

6EA Using a set net in the waters described in r 6EA(2), other than a flatfish set net during the period commencing on 1 April in each year and ending on 30 September in that year 500
