Regulations

- 1 Title
 - These regulations are the Animal Products (Fees, Charges, and Levies) Amendment Regulations 2009.
- 2 Commencement
 - These regulations come into force on 1 July 2009.
- 3 Principal regulations amended
 - These regulations amend the Animal Products (Fees, Charges, and Levies) Regulations 2007.
- 4 Schedule 1 amended
 - (1) Part 1 of Schedule 1 is amended by adding the items set out in Schedule 1 of these regulations.
 - (2) Part 7 of Schedule 1 is amended by omitting the items relating to **establishment charge** and **circuit charge** and substituting the items set out in Schedule 2 of these regulations.
- 5 Schedule 2 amended
 - (1) The item relating to lambs, bobby calves, goats in clause 1 of note 3 of Schedule 2 is amended by omitting “\$0.09” and substituting “\$0.10”.
 - (2) The item relating to sheep in clause 1 of note 3 of Schedule 2 is amended by omitting “\$0.08” and substituting “\$0.11”.

(3) The item relating to cattle, horses in clause 1 of note 3 of Schedule 2 is amended by omitting “\$0.69” and substituting “\$0.76”.

1 Establishment charge

A Basic hourly charge on export and game sectors

For each hour normal time (but not penal time hours or 1 or double time hours) spent by a verifier in verification functions \$38.04

B Hourly charges for verifiers

(1) Veterinary verifier—

(a) non-shift rates—

per hour \$68.12
per hour at 1 time \$82.61
per hour at double time \$110.15

the relevant rate specified in paragraph (a), plus an additional rate of—

- (b) shift rates
- (i) \$30.00 per shift per verifier for evening shift
 - (ii) \$41.00 per shift per verifier for night shift

the relevant rates specified in paragraphs (a) and (b), plus an additional rate of—

- (c) penal rates
- (i) \$27.54 per hour per verifier for penal time worked at penal rate 0.5
 - (ii) \$55.07 per hour per verifier for penal time worked at penal rate 1.0

(d) reserve rate \$55.07 per hour for each hour worked by a reserve verifier

(2) Supervising veterinary verifier—

(a) non-shift rates—

per hour \$72.50
per hour at 1 time \$89.18
per hour at double time \$118.91

2 Circuit charge

A *Basic hourly charge on primary processors who slaughter or dress animals other than fish*

Charge for each hour spent by a verifier in verification function for animals other than fish \$20.97 per hour

B *Basic hourly charge on secondary processors (other than processors of fish and operators of coolstores or other storage premises)*

Charge for each hour spent by a verifier in verification function \$20.97 per hour

C *Annual charge for coolstores or other storage premises, and for processors of fish*

(to be pro-rated on a monthly basis where verification contract for less than a full year)

(a) coolstores or other storage premises, per coolstore or other premises \$1,100.00 per annum

primary processing (including on a fishing vessel) of fish other than bivalve molluscan shellfish \$549.00 per annum

(c) primary processing of bivalve molluscan shellfish \$1,547.00

D *Monthly charge for fishing vessels*

Charge per vessel (in addition to any relevant charge under item C) \$20.35

E *Hourly charges for verifiers*

(for all verification activities)

(1) Non-veterinary verifier—

(a) non-penal rates—

per hour (excluding seafood and coolstore premises) \$93.04

per hour for seafood and coolstores premises \$93.04

per hour at 1 time \$128.85

per hour at double time \$171.80

the relevant rate specified in paragraph (a), plus an additional rate of—

- (b) penal rates
 - (i) \$57.00 per hour per verifier for penal time worked at penal rate 0.5
 - (ii) \$85.90 per hour per verifier for penal time worked at penal rate 1.0

(a) non-penal rates—

per hour (excluding seafood and coolstore premises) \$93.04

per hour for seafood and coolstores premises \$93.04

per hour at 1 time
per hour at double time
