

Wildlife Sanctuary (White Rocks, Duffers Reef, and Sentinel Rock) Order 1966
(SR 1966/131)

- Refer to Conservation Act 1987 (1987 No 65). In force 1 April 1987 by section 1(2) of that Act. See section 65(4) of that Act for amendments made by section 65(3) of that Act being deemed made by regulations.

PURSUANT to the Wildlife Act 1953, I, Brigadier Sir Bernard Edward Fergusson, the Governor-General of New Zealand, hereby proclaim as follows:

Contents

1

- (1) This Proclamation may be cited as the Wildlife Sanctuary (White Rocks, Duffers Reef, and Sentinel Rock) Order 1966.
(2) This Proclamation shall come into force on the day after the date of its notification in the Gazette.

- In this Proclamation, unless the context otherwise requires,
The Act means the Wildlife Act 1953
Director-General means the Director-General of Conservation
Regulation 2; “Director-General”: this definition was inserted, as from 1 April 1987, by section 65(3) Conservation Act 1987 (1987 No 65).
Sanctuary means the areas described in the Schedule hereto
“Secretary”: this definition was revoked, as from 1 April 1987, by section 65(3) Conservation Act 1987 (1987 No 65).

- The areas described in the Schedule hereto are hereby declared to be a wildlife sanctuary for the purposes of the Act, subject to the conditions specified in clauses 4 to 6 of this Proclamation.

- No person shall enter the sanctuary except
 - (a) Rangers under the Act while in the lawful execution of their duty;
 - (b) Seafarers entering through distress of weather;
 - (c) Any other person authorised in writing by the Director-General.Regulation 4 was amended, as from 1 April 1987, by section 65(3) Conservation Act 1987 (1987 No 65), by substituting the words “Director-General” for the word “Secretary”.

- No person shall, except with the written authority of the “Director-General”,—

- (a) Hunt or kill, take for any purpose, molest, capture, disturb, harry, or worry any living creature in the sanctuary:
- (b) Take, destroy, or disturb the eggs or spawn of any living creature in the sanctuary:
- (c) Take for any purpose or interfere with vegetation of any description in the sanctuary:
- (d) Introduce into or liberate in the sanctuary any living creature or the eggs or spawn of any living creature:
- (e) Introduce into or plant in the sanctuary any vegetation of any description or the spores or seeds of any vegetation of any description:
- (f) Burn or clear by any means whatsoever any trees, shrubs, grasses, or other plant life on the sanctuary:
- (g) Light any fire or do anything likely to cause a fire on the sanctuary:
- (h) Take any firearms or explosives on to the sanctuary or use any firearms or explosives in the sanctuary.

Regulation 5 was amended, as from 1 April 1987, by section 65(3) Conservation Act 1987 (1987 No 65), by substituting the words "Director-General" for the word "Secretary".

- No person shall deposit rubbish or leave litter in the sanctuary.

Schedule

White rocks, Duffers Reef, and Sentinel Rock Wildlife Sanctuary (Marlborough land district, Marlborough county)

ALL those rocks or islands known as White Rocks situated approximately 100 chains north-west of Cape Koamaru in Block XXII, Gore Survey District.

Also all those rocks forming Duffers Reef, situated to the west of Forsyth Island in Blocks V and XXV, Gore Survey District, and Block XVI, Orieri Survey District.

Also Sentinel Rock and adjacent small rocks situated approximately 140 chains east of Te Kakaho Island in the Chetwode Islands in Block XXVI, Gore Survey District.

Those rocks and islands being as delineated on the plan marked 46/29/432, deposited in the Head Office, Department of Internal Affairs, Wellington, and thereon coloured red.

Together with the foreshore of those rocks and islands, being such parts of the bed of the sea as are covered and uncovered by the flow and ebb of the tide at ordinary spring tides.
