1 Short title

This regulation may be cited as the *Gas Pipelines Access (Queensland) Regulation 2000*.

2 Application for review

An application for review of a decision under the Gas Pipelines Access (Queensland) Law¹ must—

- (a) be in the form approved by the chairperson of the tribunal; and
- (b) be signed by or for the applicant; and
- (c) state the grounds on which the applicant seeks review of the decision.

¹ Part 4 of the Act, and part 6 of schedule 1 to the South Australian Act forming part of the Gas Pipelines Access Law, contain other provisions about the review of decisions.
