## 1 Short title

This notice may be cited as the *Plant Protection (Vegetable Leafminer—Pest Declaration) Notice 2008*.

*Note—*

Under section 4(3) of the Act, this notice remains in force until whichever of the following first happens—

- (a) the commencement of a regulation prescribing vegetable leafminer to be a pest for the purposes of the Act;
- (b) the end of 3 months.

## 2 Definition

In this notice—

*vegetable leafminer* means *Liriomyza sativae* Blanchard.

## 3 Pest declaration—Act, s 4(2)

Vegetable leafminer is declared to be a pest for the Act.
