Citation

1. These Rules may be cited as the Boundaries and Survey Maps (Prescribed Fees) Rules.

Fees

2.

—(1) The fees specified in the second column of the Schedule shall be paid to the Chief Surveyor in such manner as he may determine in respect of the matters specified in the first column thereof.

(2) The fees specified in the second column of the Schedule shall be payable in advance for surveys, including demarcation and emplacement of boundary marks, performed by the Chief Surveyor and for any related works and services.
