CHAPTER C-50.2 REG 25

The Crown Minerals Act

Title

1 These regulations may be cited as *The Crown Minerals Transfer Regulations, 2005*.

Interpretation

2 In these regulations, “**pre-converted certificate of title**” means a certificate of title as it existed before being converted pursuant to section 195 of *The Land Titles Act, 2000*.

Transfer of certain Crown interests, Crown minerals and Crown mineral lands

3(1) The portion of the Crown’s interest in the Crown minerals and Crown mineral lands set out in the pre-converted certificates of titles that are listed in Part I of the Appendix is transferred to the Potash Corporation of Saskatchewan Inc.

(2) The Crown minerals and Crown mineral lands set out in Part II of the Appendix are transferred to V.O.A. Developments Ltd.

(3) The beneficial interest in the Crown minerals and Crown mineral lands described in the mineral trust certificate that is set out in Part III of the Appendix and that is to be issued by the minister after the coming into force of this section is transferred to V.O.A. Developments Ltd.

Appendix**PART I***[Subsection 3(1)]***In Part I:**

- (a) **“All”** means the full section of land as noted on a pre-converted certificate of title;
- (b) **“E/2”** means the east half of a section of land as noted on a pre-converted certificate of title;
- (c) **“LSD”** means a legal subdivision of land as noted on a pre-converted certificate of title;
- (d) **“Meridian”** means west of the meridian;
- (e) **“N/2”** means the north half of a section of land as noted on a pre-converted certificate of title;
- (f) **“NE”** means the north-east quarter of a section of land as noted on a pre-converted certificate of title;
- (g) **“NW”** means the north-west quarter of a section of land as noted on a pre-converted certificate of title;
- (h) **“S/2”** means the south half of a section of land as noted on a pre-converted certificate of title;
- (i) **“SE”** means the south-east quarter of a section of land as noted on a pre-converted certificate of title;
- (j) **“SW”** means the south-west quarter of a section of land as noted on a pre-converted certificate of title;
- (k) **“W/2”** means the west half of a section of land as noted on a pre-converted certificate of title.

The interests shown in Column 7 in mines and minerals that are described on the pre-converted mineral certificates of title listed in Column 6 and that continue to be held by the Crown in right of Saskatchewan are transferred in accordance with subsection 3(1) of these regulations.
